3. Continue following City-wide IPM Policy, including monitor park conditions, and implementing IPM best practices based on acceptable established thresholds.
4. Create SOPs for utilization of select chemical control methods.
5. Identify funding and control methods to aggressively target pest infestations in City Parks.
