Mission: Provide prevention and emergency response services for crime, fire, medical, hazardous, and disaster-related situations.

The Public Safety Capital Improvement Program included in the Public Safety City Service Area supports infrastructure improvements necessary to provide effective emergency response services. On March 5, 2002, 71.7% of the voters in San José approved Measure O, the "9-1-1, Fire, Police, Paramedic and Neighborhood Security Act" (Neighborhood Security Act Bond Measure). This bond measure, which authorized the City to issue General Obligation Bonds in an amount not to exceed \$159 million to fund both Police and Fire Department capital improvements, significantly increased the resources available to add, relocate, and renovate public safety facilities.

With the exception of the Fire Station 37 project, all of the Public Safety Bond projects have been completed. The Fire Station 37 project has been deferred pending the identification of a funding source(s) to close the budget gap to build and operate the station. Because Fire Station 37 is not moving forward at this time, a funding shift is approved to reallocate the Bond funds to eligible fire station remediation projects that would otherwise be budgeted in the Fire Construction and Conveyance (C&C) Fund and allocate the C&C funds to a Fire Station 37 reserve. This would allow the use of the remaining bond funds while preserving funding for Fire Station 37.

In addition, a portion of C&C Tax receipts (8.4% annually) is allocated to the Fire Department for ongoing fire safety equipment, facilities, and some emergency fleet apparatus needs. The Communications Capital Program, which is part of the Strategic Support City Service Area, also supports public safety efforts with the replacement of Police and Fire communications equipment.

³ Projects are considered "completed" when final cost accounting has occurred and the project has been accepted; projects are considered "on budget" when the total expenditures do not exceed 101% of the baseline budget.
