#### INFORMATION

#### Background

At a City Council meeting, a question was asked about the number of employees in the Police and Fire Department Retirement Plan who retire with a retirement benefit at 90% of final average salary. The purpose of this memorandum is to provide follow-up information regarding pension benefits for employees in the Police and Fire Department Retirement Plan. In addition, this memorandum provides information regarding the pension amount for retirees in the last ten years from the Police and Fire Department Retirement Plan.

#### Analysis

Defined-benefit pensions are typically based on a formula that determines an individual's pension. These formulas are often referred to by abbreviated titles such as "3%@50" or "2.5%@55."

The most important factors in the formulas are years of service, age, and final average salary. Thus, depending on a plan's specific formula, an individual's pension is dependent on their age, their years of service, and their final average salary.<sup>1</sup>

Defined-benefit pensions may also have a maximum benefit<sup>2</sup> after a certain number of years of service. In San Jose, for example, the maximum benefit is achieved after 30 years of service. Benefits have been enhanced several times beginning in 1996 when the formula and maximum benefit was increased from 75% to 80%. Subsequent changes in the formula increased the

maximum benefit to 85% and then to 90%. The chart below shows the current benefits for sworn police and fire employees with 20 to 30 years of service.<sup>3</sup>

As the chart indicates, an individual's benefit varies significantly depending on their years of service. For example, a police officer with 20 years of service will receive 50% of their final average salary, whereas a police officer with 30 years of service will receive a benefit of 90% of their final average salary. It should be noted that although both the Police and Fire formulas have a 90% benefit after 30 years of service, the formulas leading up to 90% are different.

A base retirement benefit of 90% of an individual's final average salary is achieved only by those employees with 30 years of service.

Attached is information regarding the pension benefits received by retirees of the Police and Fire Department Retirement Plan since 2001. This information includes the 3% fixed annual increase (COLA) currently received by retirees, but does not include the value of retiree healthcare benefits. A summary of the information attached is below.

#### Note:
