- Ability to fund future operating and maintenance costs




City of San José Budget Overview






Historical Comparison of Five-Year CIP






2017-2021 Source of Funds



Total Source of Funds: \$2.3 Billion




Major Capital Tax Revenues






2017-2021 Use of Funds
