# **HUMAN RESOURCES**

1. Appeal regarding reallocation of civilian positions in the Court Liaison Unit (CLU) of the San Jose Police Department from Office Specialists to the Police Data Specialists classification.

As indicated by Director of Employee Relations/Human Resources, Jennifer Schembri, MEF and the City have reached an agreement related to these reallocations. They will not be moving forward at the request of the affected employees.

2. Appeal of Denial of Position Reallocation Request for Jeff Anderson, Environmental Services Department (ESD).

Jeff Anderson offered remarks indicating that duties and responsibilities of his position more accurately match the classification of Division Manager than that of Environmental Services Program Manager.

Director of Employee Relations/Human Resources, Jennifer Schembri spoke on behalf of Human Resources decision to deny the reallocation request, presenting the opinion that the position in question is appropriately classified as Environmental Services Program Manager.

Both parties responded to questions from the Commission. The Commission, noting several appeals for reallocation requests for this position with ESD, requested that Human Resources and the Department of Environmental Services conduct a classification and compensation study for this classification to adequately determined the cause of this conflict.
