Barking Dog Information Sheet

The sound of a dog barking usually affects people in one of two ways: Many dog owners may be oblivious to the sound while others consider it to be a major disturbance. Barking dogs constitute the vast majority of noise complaints that we receive at San Jose Animal Care and Services and there are some things you can do about it.

Train, Train, Train

Most barking dogs have a common theme: bored, backyard dogs.

By nature, dogs are pack animals and as the owner, you and your family become their "pack." They look to you for food, water, shelter and companionship and it is the absence of the last element that can contribute to excessive barking. By barking, your dog is telling you that he needs your attention. Barking also relieves frustration and provides entertainment from boredom. So....how can you help? Hopefully, this sheet will give you some ideas.

Exercise: A tired dog is a quiet dog. One of the quickest ways to get a dog to stop barking is to tire it out. Two or more hours of vigorous exercise will ensure that your dog is too tired to bark. If you can't spend that much time with him, there are other ways to exercise your animal and keep him occupied.

Kongs: Kongs are rubber toys that you can open and place food inside (available where dog supplies/food is sold). The dog will spend his time trying to get the food. If you make the dog work for his food, it challenges him mentally and occupies his mind. If it's easy to extract the food, try placing peanut butter in the Kong and freezing it.

Socialization: Incorporate the dog into *your* pack. By making him part of your household he will not get lonely. If possible, keep him indoors with a radio or TV to keep him company. This will also mask outside noises that cause him to bark. Also, if he's alone, place him in an area away from a lot of stimuli, (i.e. foot traffic, outside noises, etc.); this will take away his need to protect his "territory." If your dog is a "nervous" type, confining him to an indoor crate may also have a calming effect. Don't be afraid to experiment. Different things work for different dogs – find what works for yours.

Training and Training Aids: Teaching your dog to bark and stop barking on command is one of the best ways to control barking. Work with an obedience trainer to help you with this. Also, there are commercial bark collars that are available to condition the dog to stop barking by emitting a small charge or a harmless chemical agent (citronella) every time he barks. There are also many barking deterrents available commercially. You can search online using the phrase "barking deterrent" to find many different devices that can help both dog owners and those that are disturbed by dog barking.
