| <ul style="list-style-type: none"> • <u>Fundraiser</u> where event proceeds benefit a civic, cultural, educational or charitable organization that provides services to City residents or businesses • <u>Allowed Examples:</u> <ul style="list-style-type: none"> ○ Somos Mayfair, Latina Coalition, AACI, PACT, WPUSA, SV Crime Stoppers, SJ Police Foundation Bowling for Badges, Rotary Club, Nonprofit Fundraisers ○ San Jose public school fundraiser ○ Silicon Valley Chamber of Commerce Legends & Leaders (proceeds benefit civic organization providing services to City businesses) ○ Teatro Vision, Tabard Theatre Company, Happy Hollow Foundation Fundraiser.
