# Wednesday, May 8, 2019

## V. Consent Calendar

A. Approve the minutes for April 10, 2019

B. Vice Mayor Jones' welcome – Vice Mayor Chappie Jones

The Vice Mayor introduced himself, spoke about his previous experience as a Neighborhoods Commissioner, and about the value of the Commission.

## A. Roundtable Reports; various Commissioners

- D8: Community college development site is a big concern and the community is reaching out to the developer; they are looking forward to getting some streets repaired; there continue to be a lot of car and home daytime break ins.
- D9: There was a large community meeting to discuss the murder of Bambi Larson and their fears of the homeless throughout the district. They are also worried about the continued traffic along the length of the district.
- D10: Many residents are also worried about what happened with Bambi Larson. Commissioner Labosky requested a future Commission presentation on the City's sanctuary policy.
- D1: The budget poll was shared throughout the community and sent responses back to the City. They also put out information about the CERT Trainings available for emergency response.
- D2: Southern Division Police Station is open; High Speed Rail continues to be a concern; at the next meeting Transportation Dept. staff will attend; illegal dumping along the rail tracks
- D3: Church that is helping homeless is seeking City support; working with ACT for Mental Health
- D4: N/A
- D5: Proposed developments in along the Alum Rock Corridor is bringing in a lot more residents so parking and traffic is huge concern. Residents want parking permits.
- D6: D6 just completed CERT training with the Office of Emergency Management; Councilmember David had a roundtable discussion with the D6 Leadership Group about the placement of Hope Villages.
- D7: Seventrees Neighborhood is concerned with the RVs and people sleeping in cars along the street (not the Safe Parking Program participants, but others); bringing a lot more suspicious activity. Tully Ball Fields were cleaned out, and the parking lot will be parked at night. Gun violence press conference is happening soon.
