# V. Reports

A. Chair – Roma Dawson

Chair Dawson reported on the City Council Priority-Setting Session City Council Priority-setting session held on March 8. She noted that Councilmembers Carrasco and Peralez, along with Arenas (participating remotely) had seeked to include the arts as a priority. She also thanked all Commissioners who attended the February 5<sup>th</sup> Salt-Stained exhibit reception in the Rotunda.

- B. Public Art Director Michael Ogilvie Reported on:
  - 1. The Litter-ature event at City Council was great, celebrating 10 poems being places on 500 newly designed public waste recepticles, each with a custom background designed by artist Carlos Perez. The poems were selected from 300 entries by students.
  - 2. A public art workshop he presented to San Jose State University students on March 12<sup>th</sup> and another public art presentation on April 8<sup>th</sup> for the Almaden Valley Community Assn.
  - 3. Still working with the City's Budget Office on resolution of the how much of the Measure T bond funds are able to be allocated for public art funding.
