### René de Guzman

Senior Curator of Art, Oakland Museum of California

Mr. de Guzman is the Director of Exhibition Strategy and Senior Curator of Art at the Oakland Museum of California. His recent projects include the upcoming exhibition RESPECT: Hip-Hop Style & Wisdom and the groundbreaking exhibition All Power to the People: Black Panthers at 50 (2016), which drew record-breaking attendance for OMCA. Mr. de Guzman directed The Oakland Standard, an artistic innovation initiative that looks at new ways to engage audiences through creative practices. He joined the Museum in 2007 to complete renovation and reinstallation of the Gallery of California Art. Previously, he helped start Yerba Buena Center for the Arts (YBCA) a multidisciplinary contemporary art center in San Francisco. During his 15-year tenure at YBCA, he provided early support for some of the Bay Area's leading artists. His career is marked by a commitment to community and artistic experimentation. Mr. de Guzman earned his BFA in art practice at the University of California, Berkeley and his artworks are in collections including the Berkeley Art Museum and the San Jose Museum of Art. He is currently Adjunct Professor in the Graduate Division of the Curatorial Studies Program at the California College of the Arts.

## **Renee Hayes**

Ms. Hayes served as the Associate Director of Grants for the Arts/San Francisco Hotel Tax Fund (GFTA) for 22 years.
