*** Notes:**

- 1) Commission Size and Representation: Effective July 1, 2013 the Commission has 11 members; members are appointed to each represent a specific Council District or appointed by the Mayor as a Citywide representative, as indicated on the roster above.
- 2) Length of Terms: Effective 7/1/13 a Full Term is 4 years however during the process of phasing this in, some new appointments may be for shorter length of time; for appointments made prior to 7/1/13, a Full Term was 3 years.
- 3) Eligibility for reappointment: Per the City Clerk, an appointment to serve a partial term of 18 months or more is considered a full term, in which case the Commissioner is eligible for only 1 more full term; appointment to a partial term of less than 18 months is NOT considered a full term in which case the Commissioner is eligible to be reappointed for 2 full terms.
