

SPECIAL MINUTES OF THE CITY COUNCIL COYOTE CREEK FLOOD

SAN JOSÉ, CALIFORNIA

THURSDAY, MARCH 9, 2017

The Council of the City of San José convened in Special Session at 3:00 p.m. in the Council Chambers, City Hall.

INTRODUCTION

Mayor Sam Liccardo and City Manager Norberto Dueñas offered opening comments.

2017 COYOTE CREEK FLOOD

Deputy City Manager, David Sykes offering insight into the cause of flooding and tools for decision making, and Director of Public Works Barry Ng followed up outlining damage to each area affected.

Deputy City Manager, David Sykes followed up with six key points: (1) The City of San José accepts responsibility for not giving adequate and timely notice to San José residents and businesses about the potential for flooding on the Coyote Creek and the need to evacuate.

(2) The City relied on data from the Water District, and although well-intended, the information was fundamentally flawed; (3) the City and the Water District need to improve early warning notification so that residents can better prepare for potential flooding, and evacuation; (4) The City did not have an effective means to communicate in a timely manner with our most vulnerable residents; (5) The City immediately planned and executed an effective multifaceted recovery process following flood; (6) To make sure this doesn't happen again, the Water District must accept responsibility to protect the communities of Santa Clara County from floodwater and storm water in the district.

Director of Communications, David Vossbrink continued with how we can better notify the public, and Director of Public Works Barry Ng covered storm monitoring, preliminary insights, and creation of a flood threat matrix. Deputy City Manager, Civic Innovation and Digital Strategy, Kip Harkness concluded with a recovery update.

City Attorney Richard Doyle provided an initial assessment of the responsibilities for maintenance of the creeks.

Mayor Sam Liccardo opened the floor for public comment.

<u>Public Comment</u>: Seventy-one members of the public spoke, expressing the devastating impact the flooding had on their homes and lives, expressing outrage for the minimal warnings provided and the need for improved communication. Concerns, observations and recommendations were expressed.

Extensive Council discussion followed. Deputy City Manager, Civic Innovation & Digital Strategy, Kip Harkness responded to questions regarding public health issues. Rick Callender, Government Relations Manager, Santa Clara Valley Water District, responded to questions from Council.

Action: Upon motion by Councilmember Johnny Khamis, seconded by Councilmember Sergio Jimenez and carried unanimously, the Coyote Creek Flood After Action Report was accepted, with staff directed to implement the identified plans to improve short-term emergency response and public communications in the event of additional major weather or flooding events this season; and staff was directed to identify long-term needs related to flooding, notification or residents, and emergency management and return to Council through the budget process. (8-0-3. Absent: Jones, Nguyen, Rocha.)
