What is Deferred Action for Childhood Arrivals (DACA)?

DACA is a temporary immigration benefit and relief from deportation for certain undocumented individuals who came to the U.S. as children. A person with DACA can get a work permit for two years and a Social Security Number. In California, DACA-recipients can get a regular driver's license and full-scope Medi-Cal. DACA can be renewed, but it is not forever.

The Supreme Court is considering a case regarding DACA. What is the current status of the program?

The Supreme Court is considering whether Trump's attempts to terminate the program are lawful. A decision is expected sometime before June 2020. In the meantime, DACA renewals are currently being accepted and current **DACA-recipients are strongly encouraged to renew as soon as possible.** Unfortunately, new DACA applications are no longer being accepted.

The application fee is very high. Can I apply for a DACA scholarship?

Yes! Scholarships for the USCIS application fee of \$495 are available to those who qualify. To receive an eligibility screening by an immigration attorney or accredited representative, visit one of our partner organizations (see reverse) or attend one of our free DACA Renewal Application Workshops. The Trump Administration has proposed increases in DACA renewal application fees. We encourage DACA-recipients to renew as soon as possible in case application fees increase.
