### **BACKGROUND**

The 2020-2021 Proposed Operating Budget was released on May 12, 2020 and the Fees and Charges Report was released on May 13, 2020. Subsequent to the release of those reports, the Administration updated specific pages in both documents to correct minor errors and inadvertent omissions during the initial preparation. These changes also included updates to the City Service Area Dashboards as raised by Councilmember Davis during the Budget Study Session on May 14, 2020. Both the website and hardcopy published budget documents include the updates noted below.

#### **ANALYSIS**

The following is a table summarizing the updated changes to the 2020-2021 Proposed Operating Budget and the 2020-2021 Proposed Fees & Charges Report. The most significant issue was the initial omission of the funds for the Development Fee Program. New for 2020-2021, these cost recovery programs that are currently budgeted in the General Fund will be allocated to their respective special funds to improve transparency and internal administration. Though the costs associated with the Development Fee Programs were correctly allocated to departmental budgets, the final budget document was not correctly updated to initially display the Source and Use Statements.
