File No. PDC18-016 & PD19-011 - Planned Development Rezoning from the R-2 Two-Family Residence and CO Commercial Office Zoning Districts to a CP(PD) Planned Development Zoning District and Planned Development Permit to allow the demolition of three existing buildings totaling approximately 19,000 square feet, and the construction of a four to seven-story mixed-use building with up to 226 residential units and approximately 1,400 square feet of ground-floor commercial.
