To Our Partners in the Community,

Below are reminders on how to review and more information on the different ways you can comment on San José's new <u>Draft 2020-25 Consolidated Action Plan and Draft FY 2020-21 Annual Action Plan</u>, which oversee the use of federal funds for housing and community development from the U.S. Department of Housing and Urban Development (HUD).

These plans identify five-year spending priorities, a plan for the City's use in FY 2020-21 of \$14.9 million in annual funds, and a plan to spend \$32.8 million in one-time Emergency Solutions Grant funds for homelessness from the federal CARES Act.

We welcome public comments on these actions. All public comments will be submitted to HUD.
