- a. File No. PDC17-035 - Planned Development Rezoning to rezone the subject site from the A(PD) Planned Development Zoning District to the RM(PD) Planned Development Zoning District to allow up to 85 multi-family residential apartment units on an approximately 0.91-gross acre site. Project Location: 7201 Bark Lane. Council District: 1.

- b. File No. PP20-008 - An uncodified Ordinance of the City of San José temporarily extending the term of specified land use permits by two years from the set expiration date, and Tree Removal permits by eight months from the set expiration date. Project Location: Citywide.

File No. PDC19-022, PD19-018 & PT19-022 - Planned Development Zoning to rezone from a A(PD) to a A(PD) zoning district; Planned Development Permit to demolish existing residential structure and allow construction of two single-family residences and a commercial parking lot, and allow the removal an ordinance-size tree approximately 55 inches in circumference; and a Tentative Map to subdivide one parcel into three lots on an approximately 1.1-gross acre site. File No. PP20-011 - An ordinance of the City of San José amending various sections of Title 20 (Zoning Ordinance or Zoning Code) of the San José Municipal Code to: (a) amend Part 4.5, Accessory Dwelling Units, to make minor clarifying text alterations within Sections 20.30.460, ‘Single-Family Dwelling’ lot, 20.30.470, ‘Junior Accessory Dwelling Units —Single family dwelling lot,’ and 20.30.480, ‘Two-Family and Multi-Family Dwelling lots; (b) amend Part 2.5 - Transient Occupancy as an Incidental Use to a Residence, to make a minor clarifying text change to Section 20.80.150;(c) amend Part 9, Home Occupations Section 20.80.700, to include Accessory Dwelling Units; (d) amend Tables 20-50, 20-90, 20-110, and 20-150 within Sections 20.30.100, 20.40.100, 20.50.100, and 20.75.200 to change permitting requirements for day care center uses from a Conditional Use to a Special Use; and to make other technical, non-substantive, or formatting changes within those sections of Title 20 of the San José Municipal Code. Project Location: Citywide.
