## <u>Proposed Project File Nos. GP19-021, C19-041, CP20-019 & T20-020</u>

General Plan Amendment, Conforming Rezone, Conditional Use Permit, and Tentative Map to allow a General Plan Amendment from Residential Neighborhood to Downtown, a Conforming Rezone from LI and R-2 to Downtown, the demolition of existing structures and the construction of a new residential care facility (six stories) with a total of 116 assisted living units, 49 memory-care units, and 4 staff housing units, and the consolidation of seven lots into one lot.

<u>Purpose</u>: To describe the applicant's proposed project, the City's review process, and to obtain community input on the project. Comments, concerns, and questions raised at this meeting will become part of the public record and will help inform the project's design as it moves forward in the review process.
