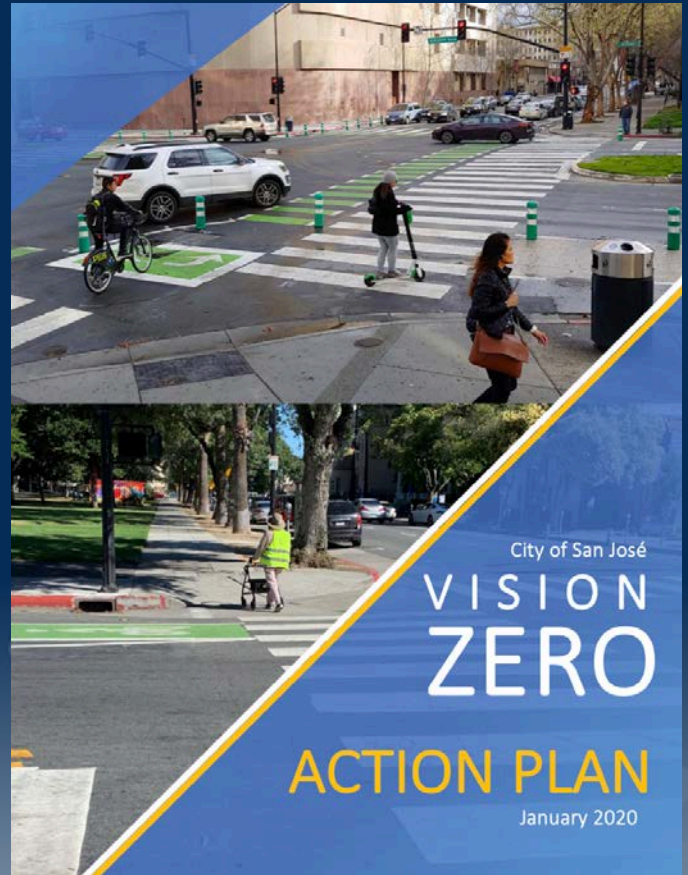

Bringing a Best Practice to San Jose

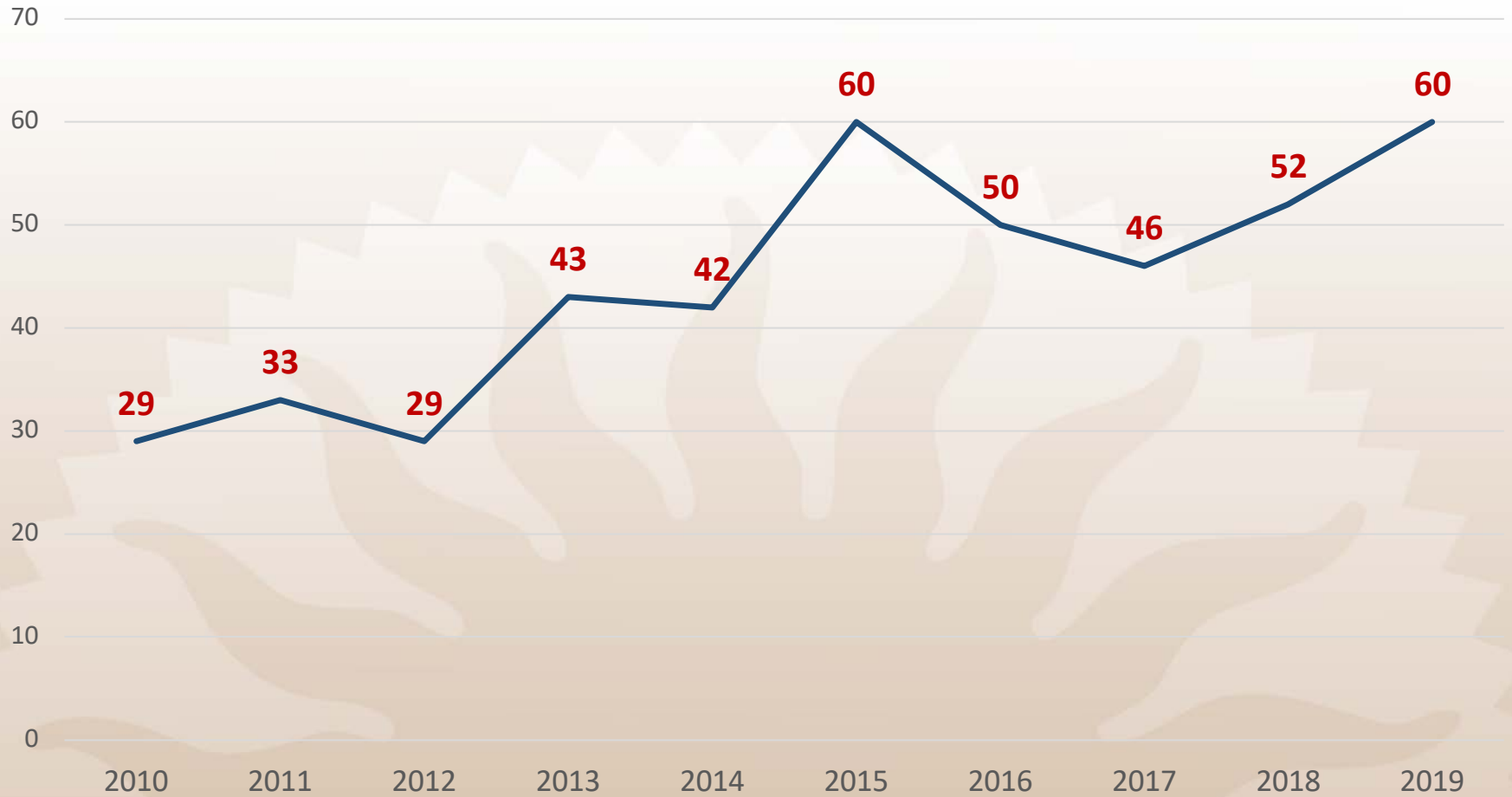

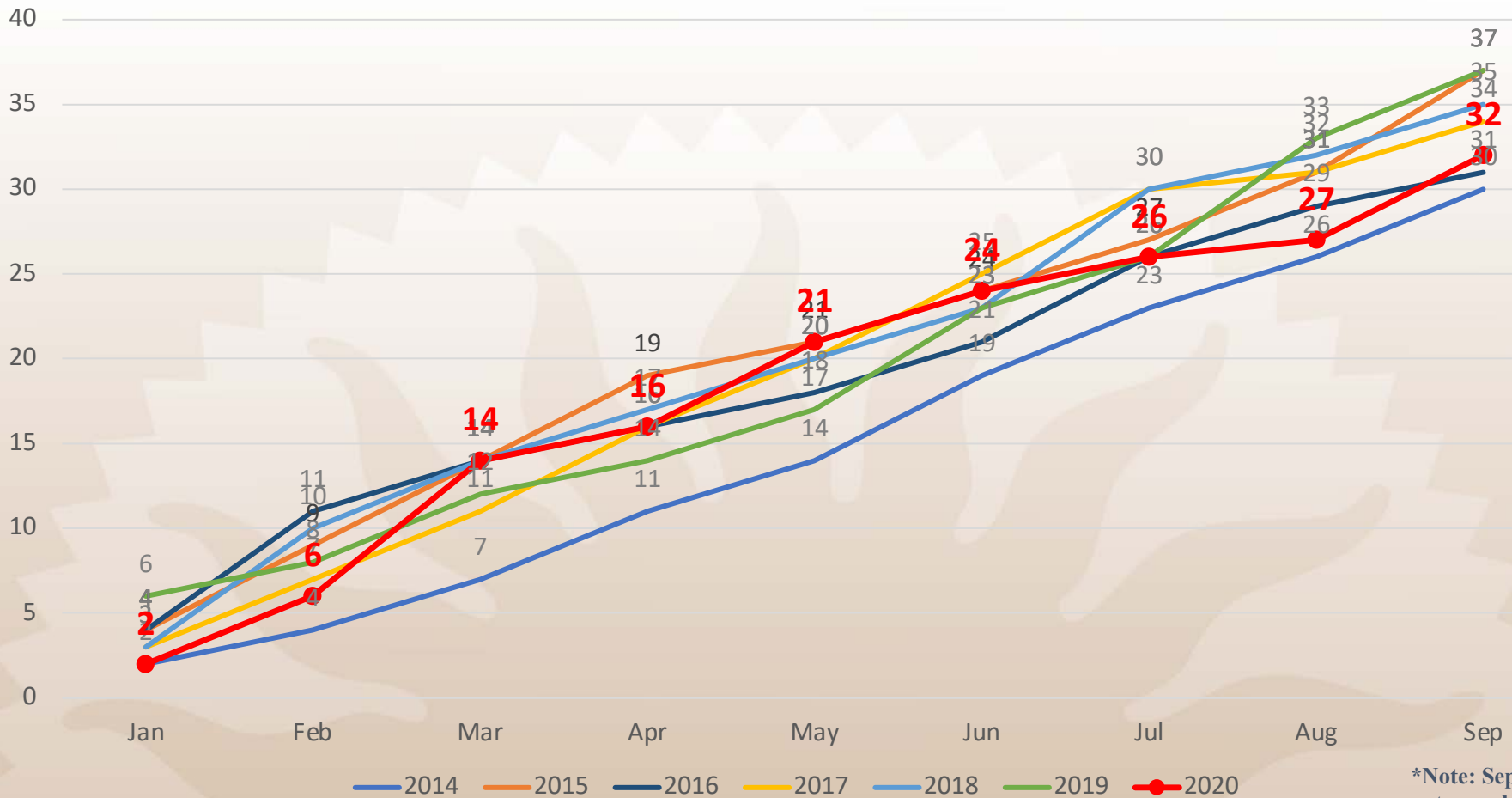
Traffic Fatalities

Cumulative Traffic Fatalities

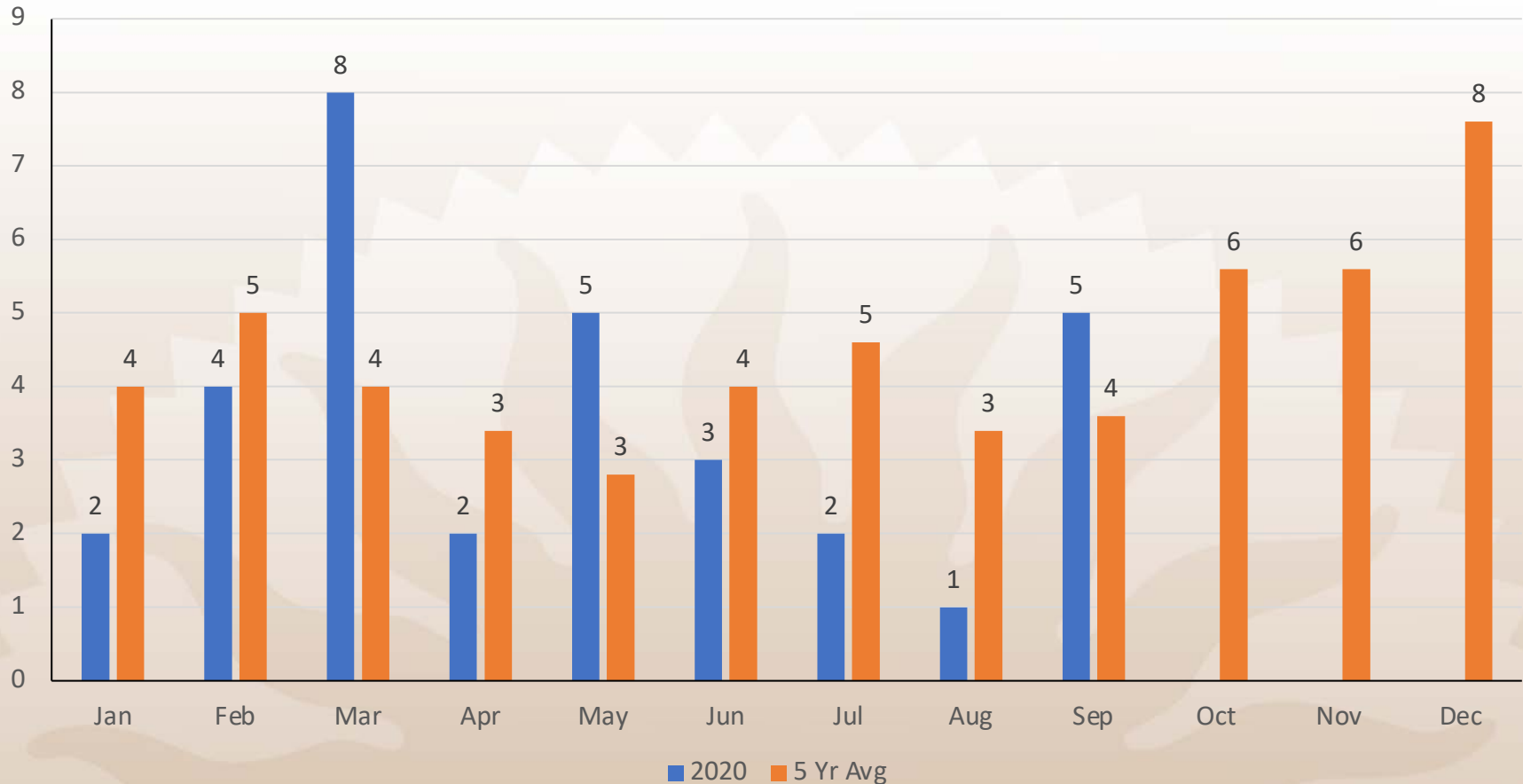
2020 by Month, vs. past 5 years (2015-2019)

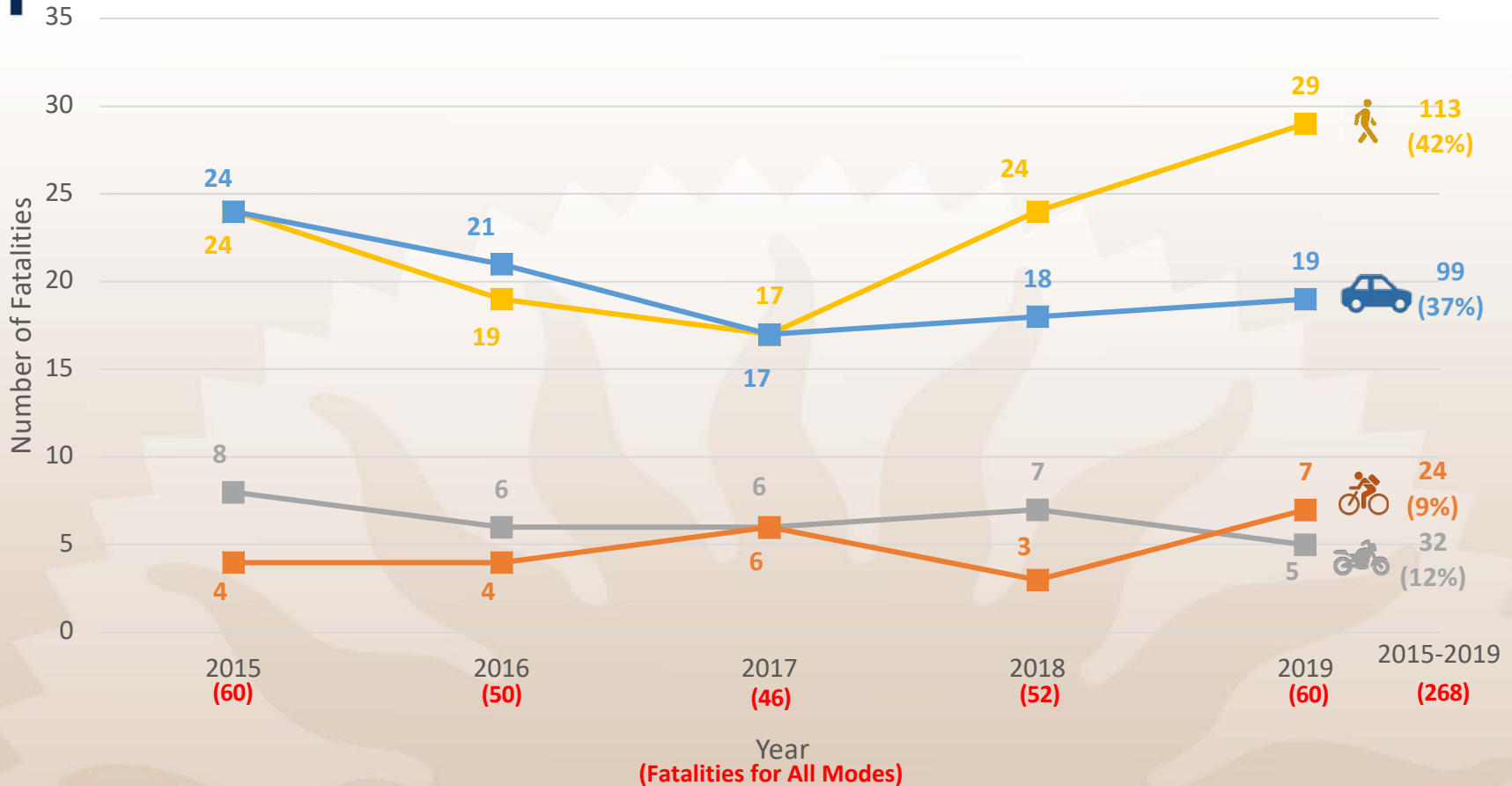
2020 by Month, vs. past 5 years (2015-2019)

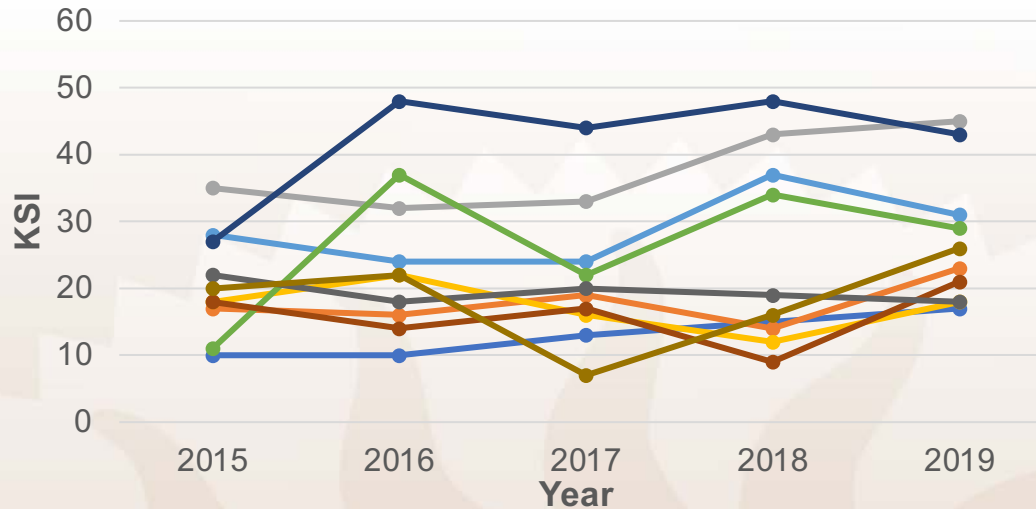

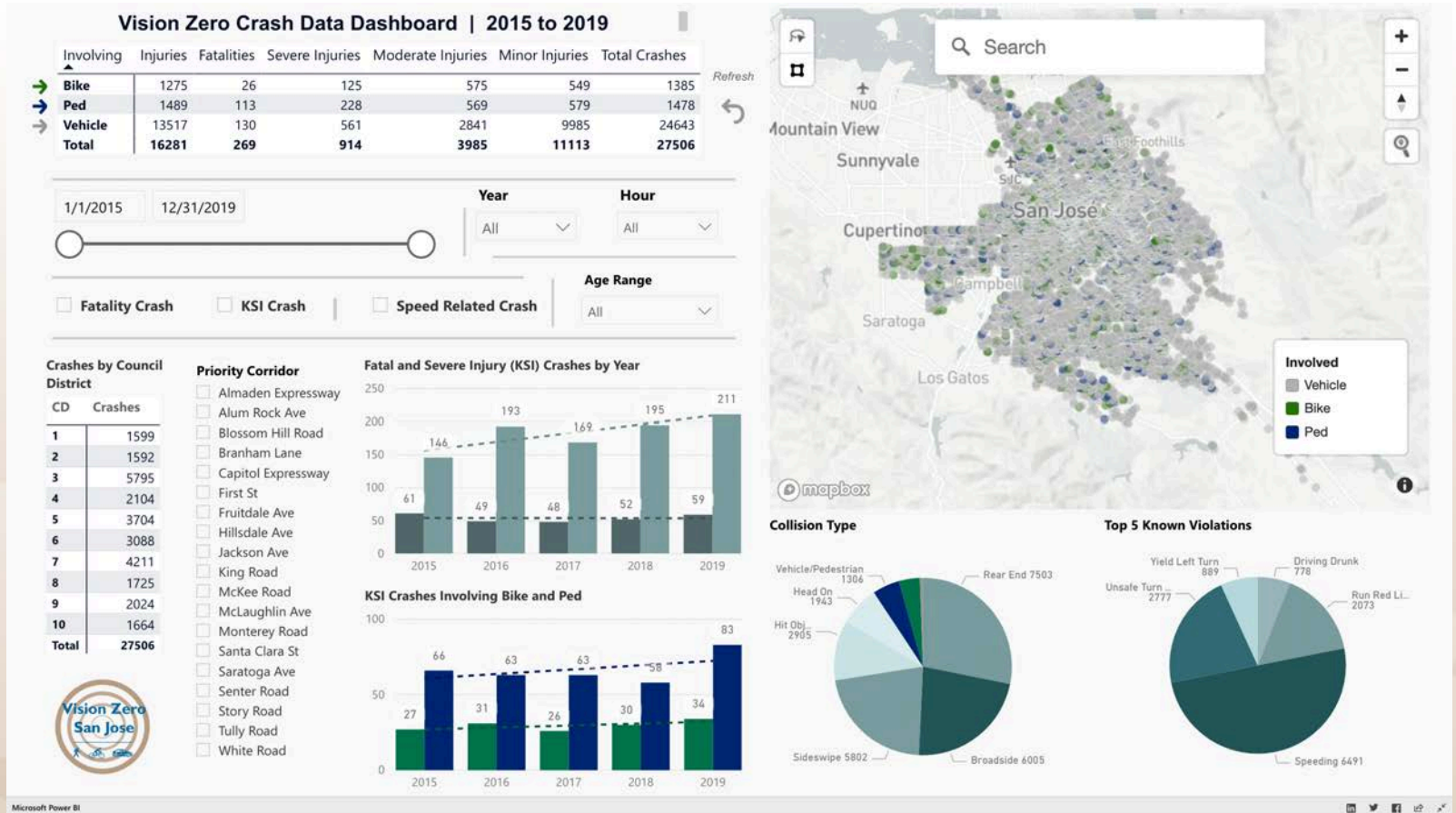
