- (e) Old Business

(1) Process for City Commissions

Staff presented a report on San Jose City Commissions and the process for BPAC to become a commission. If BPAC were to become a city commission, it would require a Council-adopted resolution and revision to Chapter 2.08 of the San Jose Municode and Council Policy 0-4 and additional staff resources.

Discussion: It is unclear if effectiveness of BPAC would increase as a Commission. Staff resources don't currently exist. The current Council liaison is appointed by the Mayor but does not serve on the Transportation and Environment Committee. Building the relationship with the current Council liaison would be useful. As a Commission, BPAC would have the ear of Council and more resources to support efforts. Need further discussion on whether to become a Commission and its pros and cons, possibly through an Ad Hoc Committee. BPAC would like to invite the Council liaison and hear the Council liaison's goals.

Motion: Committee member Knepper will draft a letter stating goals for strengthening relationship Council liaison and invite Council liaison to the next meeting. Motioned by Knepper and seconded by Broberg. Approved 10-0-0.

(2) Appoint San Jose Representative to the VTA BPAC

New protected bikeway projects under construction include: 10th St., 11th St., Lean Ave., and lane reduction projects on Naglee Ave. and Fruitdale Ave. The SJ Better Bike Plan will go to Council on Oct. 6th. The Bike Parking Program is getting upgraded with a specific focus on bike parking on commercial property. Staff requests help with outreach to business owners and commercial property owners by distributing the updated Bike Parking Brochure and sharing social media posts. Bikeways Program Manager, Nick Danty will present at a future meeting about the annual pavement maintenance program.
