Assistant Director Fukuda said that the Pond A18 Sale issue would be coming back to TPAC for consideration next month or the following month. He offered that in addition to the specifics on the sale of Pond A18 that staff could provide information on options on uses of the 800 acres planned open space and pros and cons of the levee trails.
