

PUBLIC NOTICE INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION CITY OF SAN JOSE, CALIFORNIA

Project Name: Fire Training and Emergency Operations Center Relocation Project File No.: ER20-180

Description: Public project to relocate the City's existing fire training and emergency operations facilities to the Project site. The project would result in the removal of existing structures such as solar panels, freestanding metal canopy structure, electric panels, infrastructure, and equipment, the renovation of approximately 16,000 square feet of existing building space, and construction of an approximate total of 56,393 square feet of new building area on the 26-acre project site located at 1591 and 1661 Senter Road.

Location: The project is located on approximately 26 acres at 1591 and 1661 Senter Road. Assessor's Parcel No.: 477-38-007 & 477-38-016 Council District: 7

The City has performed an environmental review of the project. Based on the review, the City has prepared a Draft Mitigated Negative Declaration (MND) for this project. An MND is a statement by the City that the project will not have a significant effect on the environment because the project will include mitigation measures that will reduce identified project impacts to a less than significant level. The project site is present on any list pursuant to Section 65962.5 of the California Government Code.

The public is welcome to review and comment on the Draft MND. The public comment period for this Draft MND begins on **Tuesday October 20, 2020 and ends on Monday November 9, 2020**.
