Special Use Permit and Tentative Map to allow the demolition of two commercial buildings, the removal of three ordinance-size trees, and the construction of one six-story multi-family residential building including 62 units and associated parking, landscaping and amenities. Nine units are proposed to be restricted as affordable for moderate-income residents.

Purpose: To describe the proposed project, the environmental review and planning processes, and obtain community input on the project and issues to be discussed in the Environmental Impact Report (EIR) analysis. Public input on the scope of the EIR is encouraged so that the review addresses all relevant environmental issues.
