As directed in the Mayor's June Budget Message for Fiscal Year 2020-2021, as approved by City Council, this action adds one-time non-personal/equipment funding of \$150,000, reallocated from the San José Police Department's overtime allocation, to establish a process to review "use of force" policies, engage the community to seek feedback on findings and recommended changes, and implement policy reforms consistent with national best practices. The process will engage the entire community, including faith leaders, social justice advocates, community leaders, criminal justice experts, the Police Officers' Association, and the San José Police Department. (Ongoing costs: \$0)

This action adds one-time non-personal/equipment funding of \$15,000 for software to support the Independent Police Auditor's (IPA) Online Complaint form in response to concerns received during recent periods of civil unrest and demonstrations in May and June 2020. The current online filing process cannot accommodate multiple, or large media files (photos, video, etc.). With the assistance of staff from the Information Technology Department and the City Manager's Office, a software provider has been identified whose platform will allow the public to file complaints easily through the IPA's website, with media attachments. (Ongoing costs: \$0)

This action reduces the Office of the Independent Police Auditor's (IPA) Personal Services appropriation by \$10,184, all in the General Fund, to reflect the anticipated expenditure savings associated with lower retirement contributions from the prepayment of the City's retirement costs for both the Tier 1 pension costs and the Unfunded Actuarial Liability in the Federated City Employees' Retirement System Plan and the Police and Fire Department Retirement Plan. By the City making annual prepayments of its employer contributions to the Retirement Plans in lieu of biweekly contributions, this will generate approximately \$13.9 million in savings in all funds, \$11.4 million in the General Fund. In the General Fund, these savings will be offset by an estimated loss in interest earnings of \$2.6 million and costs in TRANs debt service of \$1.4 million, giving a total net savings of \$7.4 million. (Ongoing savings: \$10,184)
