INFORMATION

PURPOSE

This memorandum reflects the revisions to the 2020-2021 Proposed Fees and Charges as approved by the City Council with the adoption of the 2020-2021 Budget. This document in combination with the 2020-2021 Proposed Fees and Charges document comprise the 2020-2021 Adopted Fees and Charges. It is recommended that this memorandum be retained with the 2020-2021 Proposed Fees and Charges document for a complete record of all fees and charges approved for 2020-2021.

BACKGROUND

The 2020-2021 Proposed Fees and Charges document was released on May 13, 2020 and outlined the proposed fees for the majority of fees and charges accruing to the General Fund and selected fees and charges associated with other funds. Public input on fee proposals was heard by the City Council at public hearings held on Thursday, May 21, 2020, at 1:30 p.m. and Monday, June 15, 2020, at 1:30 p.m. The proposed fees and charges were approved by the City Council with adjustments that were brought forward during the budget deliberation process through Manager's Budget Addenda (MBA) #29 that was approved as part of the Mayor's June Budget Message for Fiscal Year 2020-2021.

This memorandum serves to document the changes from the 2020-2021 Proposed Fees and Charges to the 2020-2021 Adopted Fees and Charges. This memorandum is being released in lieu of a 2020-2021 Adopted Fees and Charges book, given the minimal fee changes and the extra cost to publish a revised document.

ANALYSIS

Following is a description of each of the changes to the 2020-2021 Proposed Fees and Charges approved by the City Council (details found in Attachment A) as well as the total estimated revenues and expenditures associated with fee activities (Attachment B).

Housing Department

Rent Stabilization Program Fee

The 2020-2021 Proposed Fees and Charges Report recommended that the Rental Mediation Penalty for Apartments, under the Rent Stabilization Program Fee, remain intact in 2020-2021. However, due to the impacts of COVID-19 on the rental community, all late fees, interest and penalties associated with the Rental Stabilization Program are now suspended through June 30, 2021. This suspension will be re-evaluated for the Proposed 2021-2022 Fees and Charges Report at that time. No revenue was assumed from late fees, interest and penalties in the 2020-2021 Proposed Budget. As described in Manager's Budget Addendum #29, approved as part of the Mayor's June Budget Message for Fiscal Year 2020-2021, the Rental Mediation Penalty for Apartments is changed to "Suspended through June 30, 2021".

<u>Transportation Department</u>

Micro Mobility Permit Fee

The 2020-2021 Proposed Fees and Charges Report initially recommended that the Micro Mobility Permit Fee be increased to \$134 per permit. However, this amount was based on budget proposals that were not incorporated into the 2020-2021 Adopted Budget and incorrect assumptions that five vendors would be operating in 2020-2021 and would permit 4,000 scooters. The correct fee is \$97 per permit based on updated costs and the estimate of four vendors and 3,600 scooter permits. Based on information gathered after speaking with seven current and potential scooter vendors, it is anticipated that four vendors will provide service in 2020-2021. Estimated revenue does not change because of the updated fee.

Affordable Housing Transportation Review Fee

The Affordable Housing Transportation Review fee was approved to be changed from \$4,303 per review to \$812 per review to correct the fee, which was inadvertently included at the higher amount in the 2020-2021 Proposed Fees and Charges Report. Estimated revenue does not change because of the updated fee.

Technical Corrections

Planning, Building and Code Enforcement

Some minor fee revisions to the Planning Development Fees were approved to correct errors that occurred during the initial preparation of the 2020-2021 Proposed Fees and Charges Report as described in Attachment A. These edits do not affect the revenue estimates.
