- (e) Old Business
  - (1) VTA Bicycle and Pedestrian Advisory Committee Meeting Update

VTA BPAC Ad Hoc Committee was created to recruit a new chair. Approved staff recommendation to the VTA board to modify the Transportation Development Act to use more funding for bike and pedestrian projects. SB-743 shifts planning impact metrics from Level of Service to Vehicle Miles Traveled. Allows development projects to be denser and expedite lane reduction projects.

### (f) New Business

# (1) Presentation and Committee Input on San Jose DOT Annual Bikeways Workplan

San Jose installs bikeways by leveraging funding from the annual pavement maintenance program. Opportunity to reassess a roadway's function. Staff analyze streets which require a lane reduction or parking lane removal for the addition of bike infrastructure. Public outreach includes postcard notifications, public meetings, and special presentations. MoveSJ.org is the new public outreach online portal. The Vision Zero Team in the Department of Transportation leads projects on Vision Zero corridors. The Bike Plan 5-year Implementation and Priority Network guide DOT's bikeway recommendations for the annual pavement maintenance program. There will likely be an update to the standard operating procedures for the 2021 pavement maintenance program.

Discussion: Ideas were discussed for various ways BPAC members can provide input on an ongoing basis. Possible checklist of staff outreach activities, workshop of analysis method, and slimmed version of the roadway analysis spreadsheet. BPAC members are interested in using the San Jose app to provide input on bike lanes or potholes. Share a spreadsheet ahead of a workshop or special meeting. City staff will return to BPAC with a proposal.

# (2) Create BPAC Ad Hoc Committee on Improving BPAC's Effectiveness and Strengthening BPAC's Relationship with the City Council

Creation of an Ad Hoc Committee on Improving BPAC's Effectiveness and Strengthening Relationship with City Council is a follow-up action to last month's presentation on becoming a Commission. Ad Hoc Committee would meet outside of the BPAC meetings over the next several months and report back to the BPAC at BPAC monthly meetings. Ad Hoc Committee will present findings to the BPAC at the conclusion of its activities.

Motion: Establish an Ad Hoc Committee on "Improving BPAC's Effectiveness and Strengthening Relationship with Council" to include members Alvarado and Kahlon. Motioned by Broberg, seconded by Filip. Approved 10-0-0.
