A. Statement from the San José Human Services Commission in Support of the Santa Clara County Sanctuary Law (Chair Dickinson Goodman, 15 minutes)

Purpose: To discuss and approve a statement to City Council and Mayor Liccardo in support of the Santa Clara County Sanctuary Law as written and enforced in our city. The text of the statement, which we can edit during the meeting is: "Dear Mayor Liccardo and Honorable Councilmembers, The Human Services Commission of San José strongly supports the Santa Clara County Sanctuary Law as written (Board Policy 3.54).

Deportations do not prevent violence, as we were all tragically reminded last month. The threat of increase deportations actively harms our undocumented neighbors, friends, and family members. In solidarity, the San José Human Services Commission."
