**SUBJECT:** Concept, schematic and design development proposal by artist Brian Brush for an illuminated facade enhancement at the Market Street Parking Garage.

#### RECOMMENDATION

Review and take action on the recommendation to approve the concept, schematic and design development proposal by artist Brian Brush for an illuminated facade enhancement at the Market Street Parking Garage.

DATE OF ARTIST SELECTION: April 19, 2018

**ARTWORK DESIGN BUDGET:** \$306,000 (Funding provided through Parking Façade Enhancement dollars)

**LOCATION:** The project site is at the San Pedro/Market Street Garage 45 N San Pedro St, San Jose, CA 95113 in San José, California.

### **PROJECT DESCRIPTION**

The City of San José Public Art Program (SJPA) in conjunction with the City of San José Department of Transportation's (DOT) Parking and Downtown Operations Division are released a Request For Qualifications (RFQ) on January 12, 2018 for an experienced artist or artist-led team to develop an artwork that addresses the exterior façade of the Market/San Pedro Street Parking Garage in downtown San José. The garage is a prominent facility in San Jose's downtown core and adjacent to the vibrant San Pedro Square commercial district, a popular destination for dining, retail and other activities day and night. The goal is for an enhancement that has a visual presence 24 hours a day. The RFQ closed on February 20, 2018 and 94 applications were received.

In conjunction with the City of San José Department of Transportation's (DOT) Parking and Downtown Operations Division a neighborhood review panel was put together to select an artist to be contracted to fabricate and install the artwork. The review panel was comprised of six community members and included three (3) artists who live and work in downtown San José. The initial scoring by the review panel was done online. This scoring shortlisted the applicants to 14 artists to be reviewed.

The Artist Selection Panel met on April 19, 2018 at City Hall. The panel reviewed 14 artists from the shortlist and unanimously selected artist Brian Brush.

Brian Brush began is concept design development after a public 'visioning' meeting and a meeting with key stakeholders. During the process of development and a meeting with the Artist/DOT and other stakeholders at the site, it was noticed that visible cracking was starting to occur on the building's Glass Fiber Reinforced Concrete (GFRC) panels which cover the façade of the parking building. This forced the illuminated enhancement project to be put on hold so DOT and Public Works could provide structural analysis data. After a year of analysis, it was determined that all GFRC panels needed to be removed for safety. This significantly scaled up the illuminated façade enhancement from one side of the building to the entire building. After restructuring Brian's contract to be a design only contract, Brian set to work scaling his design for the entire façade.
