### **Proposed Projects for Review:**

1. **H20-047:** Site Development Permit to demolish an existing 4,000-square foot commercial building and allow the construction of an approximately 53,079-square foot, 80-room hotel, with a 50% parking reduction on an approximately 0.36-gross acre site located at 615 Stockton Avenue. On-site parking includes 44 spaces in a subterranean garage, accessible from Stockton Avenue.
