OVERVIEW

The Office of the City Clerk is responsible for making all official City Council records and documents accessible to the public and conducting elections for Mayor and City Council and ballot measures. Copies of the City Charter, Municipal Code, supplements to the Municipal Code, City Council meeting minutes, official documents, forms, and records are available upon request. City Council meeting agendas and synopses are available on an ongoing basis, by subscription. The majority of these documents are available on the City's website at <u>www.sanjoseca.gov</u>. The Office of the City Clerk also provides duplication of taped materials and performs special research and notary services on a fee basis.

SUMMARY AND IMPACT OF PROPOSED FEE REVISIONS

Existing Fees

In 2013-2014, a review of fees and charges was completed and adjustments are recommended to maintain cost recovery levels to the extent possible.

The City Clerk's Office revised fees and charges for 2013-2014 reflect updated salary and benefits costs, as well as overhead costs. Increases to the following fees are recommended: Duplicating Services (Audio Recording, Materials, Video Recording); Lobbyist Registration (Client Fee, Lobbyist Registration, Prorated Registration Fee, Quarterly Report Delinquent Fee); Sale of Publications and Document Copying (Agenda Subscriptions, City Charter, FAX Copies to Public, Public Documents); and Special Research/Services to maintain approximately 100% cost recovery levels.

In order to move towards full cost recovery, the fees for lobbyist registration and client fees will be increased over a two-year period.

In addition, for consistency, the Document Copying – Public Documents fee is standardized across the City to match the department with the lowest cost recovery fee for this service. This fee will increase from \$0.24 to \$0.25 per page for $8\frac{1}{2}$ " x 11" documents and \$0.25 to \$0.26 for 11"x 17" documents.

At this time, a small increase in estimated revenue is anticipated from these fee increases.

NOTIFICATION

The Proposed Fees and Charges Report was released on May 3, 2013, allowing for a minimum of 10 days for public review. Public input on fee proposals will be heard by the City Council at public hearings held on Tuesday, May 14, 2013, at 1:30 p.m. and Monday, June 10, 2013, at 7:00 p.m. in the Council Chambers.
