#### a. RECYLE PLUS PROGRAM SPECIAL ASSESSMENT LIENS

Conduct a Public Hearing to consider the adoption of a resolution confirming the Special Assessment Report of the Director of Finance and the delinquent Residential Solid Waste Collection Service Charges, Late Charges and Administrative Fees and Charges contained therein; and direct the Director of Finance to place a special assessment and secure a lien in the amount of any delinquent customer account balance against the related parcels with the Santa Clara County Tax Assessor's Office and Recorder's Office, respectively.

**b.** <u>27 CLEAVES AVENUE (261-31-025) – PROPOSED ABATEMENT</u> (Greg Peacock, Code Enforcement Inspector/ Tommy E Pugh, Property Owner)

The Director of Planning, Building and Code Enforcement requests a hearing to consider the adoption of a proposed abatement order to require the property owner by the end of fifteen (15) calendar days of the date of service of the Board's resolution in this matter:

- 1. Cut and remove overgrown grasses or other vegetation located in the left side yard, right side yard, and rear yard.
- 2. Remove any discarded wood stored in the front yard.

If the above mentioned hazards and violations are not removed, and the preventative measures are not completed within fifteen (15) calendar days of the date of service of the Board's resolution in this matter, the abatement shall be performed by a City approved contractor or service providers and the cost of the abatement may be charged to the property owner to be billed following the completion of the work and paid in full within thirty (30) days of the billing date.
