A. Director's Report (verbal)
CIP Monthly Reports
January

Vice Chair Watanabe introduced ESD Director, Kerrie Romanow who reported that the CIP Semi-annual Report would be presented at the next TPAC meeting and reminded the committee that the CIP Monthly External Reports would now be published quarterly. ESD Assistant Director, Napp Fukuda presented a flyover video of the RWF which included views of the Digesters and the new Cogeneration facility. Director Romanow shared that there would be a joint meeting of Valley Water and the City of San José on Friday, March 19. She wanted the committee to be aware that one of the items on the agenda is a Purified Water Project that Valley Water wants RWF to partner on. Director Romanow concluded the Director's Report. Vice Chair Watanabe recognized Committee Member Montano who had a question regarding if it was methane gas produced by the

digesters. Assistant Director Fukuda confirmed it was and that the gas was used by the cogeneration facility to produce power. There were no questions from the public.

5. AGREEMENTS/ACTION ITEMS

A. Report on Bids and Award of Construction Contract for 8142 – Yard Piping Improvements Phase 1 Project at the San Jose-Santa Clara Regional Wastewater Facility

Staff Recommendation:

- 1. Approve Report on bids and award of construction contract to the low bidder, Michels Corporation DBA Michels Pipeline Construction ("Michels"), in the amount of \$3,096,903, for the 8142 Yard Piping Improvements Phase 1 Project and approve a fifteen percent construction contingency in the amount of \$464,535.
- 2. Adopt a resolution adopting the Addendum to the Environmental Impact Report for the San José-Santa Clara Water Pollution Control Plant Master Plan (SCH# 2011052074), Yard Piping and Road Improvements Project, File No. PP19-063, in accordance with the California Environmental Quality Act ("CEQA"), as amended, and a related Mitigation Monitoring and Reporting Program.

Chair Liccardo presided over the meeting with the consideration of Item 5. A. ESD Assistant Director, Napp Fukuda said there was no presentation on this item and provided a brief overview. Staff was available for questions. Chair Liccardo asked if there were any questions or comments from the public or committee on this item. There were none.

B. Actions related to the Purchase Order for Rockwell Variable Frequency Drive Maintenance, Repair, and Inspection Services

Staff Recommendation:

Adopt a resolution authorizing the City Manager to:

1. Execute a purchase order with Buckles-Smith Electric (Santa Clara, CA), for Rockwell Variable Frequency Drives (VFD) Upgrade, Maintenance, Repair, and Inspection Services for a twelve-month period, starting on or about March 16, 2021 and ending on March 15, 2022, for an amount not to exceed \$650,000; and

2. Exercise up to one (1) option to extend the term through on or about March 15, 2023 for any additional necessary VFD upgrades, maintenance, repair and inspection services, subject to the appropriation of funds.
