File No. PDC20-001, PD20-005 and PT20-001 - Planned Development Rezoning from the R-1-8 Zoning District to an R-1-8(PD) Zoning District, a Planned Development Permit to allow the demolition of two maintenance buildings totaling 22,000 square feet, the removal of 10 ordinance-size trees, and the construction of 40 detached single-family houses with a private street, and a Vesting Tentative Map to subdivide two lots into 45 lots on an approximately 6.03-gross acre site.
