My name is Sandy Flores, I'm the President of Capitol Park Goss Dobern Neighborhood Association in District 5.

This email is to inform the council and the Mayor the homeless encampments have been polluting our creeks and the environment, this needs to be addressed immediately before this becomes a larger issue to take care of.

Since 2019 we've been having issues with the homeless encampment located at the Lower Silver Creek at the entrance at S. Jackson Avenue all the way to E. Capitol Expwy. The Capitol Park neighborhood has a large number of school children going back and forth to Aptitud Academy at Goss located in our neighborhood.

This is a very dangerous and unhealthy environment that is not SAFE for anyone crossing the Bambi Ln & Dobern Ave Pedestrian Bridge on a daily basis.

We had numerous illegal dumping of human waste into the creek with indecent exposal of people, car break-ins, folks going thru our garbage & recyclable bins looking for something to eat, walking across the street during peak hours of traffic, illegal dumping of trash creating a blight zone.

Right now our concern is the SAFETY for our residents who are at great risk due to this dangerous area and the environment around it.
