2022-2026 Proposed Capital Improvement Program Art in Public Places

In developing the 2022-2026 Proposed Capital Improvement Program (CIP), staff reviewed each capital program for public art funding based on revisions to the Public Art Master Plan approved

by the City Council on March 13, 2007 and in accordance with Chapter 22.08 (Art in Public Places) of the San José Municipal Code. One percent of all construction project funding is required to be allocated to public art, excluding seismic and ADA retrofits. fundina for rehabilitation, maintenance and operations, non-construction projects (such as studies), affordable housing, and the Water Pollution Control Plant. Attached is a breakdown of public art allocations in the 2022-2026 Proposed Capital Improvement Program (Attachment A) and a sampling of projects that are currently being developed (Attachment B).

As shown in Attachment A, a total of \$3.1 million is programmed for public art projects in the 2022-2026 Adopted CIP. This figure does not include the \$7.5 million in public art expenditures for 2020-2021. It also excludes outside funding from grants and consulting projects being managed by San José's Public Art Program staff. Due to the outreach and development process, the timing and completion of the projects may vary from when the funding for a project is allocated. Funds will be recommended to be carried over (rebudgeted) from 2020-2021 to 2021-2022 as necessary.

The sample project list that follows (Attachment B) includes major highlights of some of the public art projects funded through the Public Art allocations in this CIP. Given the scope and schedule of specific public art projects still under development, and determined as funding allows, not all public art projects are reflected in this document. Further detail and discussion of all specific public art projects can be found in the Annual Status Report on the City-wide Capital Improvement Program. City Council accepted the most recent report on June 15, 2020.

In accordance with the San José Municipal Code, the Public Art Five Year Work Plan for FY 2022-2026 was submitted to the Public Art Committee on April 6, 2021 and was recommended for approval and will be submitted to the Arts Commission for review and acceptance on May 17, 2021.

Art in Public Places

Performance Measures

A set of consistent and comprehensive performance measurements along with targets and goals have been established for the entire capital program and adopted for each individual CSA. Measures focus on schedule (cycle time) and project delivery cost. Please see the Budget Guide section narrative for additional information on capital performance measures. While its investment spans across each CSA, performance measures for Public Art are presented below for ease of reference.

¹ Projects are considered "completed" when final cost accounting has occurred and the project has been accepted; projects are considered "on budget" when the total expenditures do not exceed 101% of the baseline budget.

In 2019-2020, seven projects (VTA BART Berryessa Artwork; Iris Chang Park Art; Alviso Storm Pump Bas-Relief Ceramic Mural; Don Edwards Artwork; Edenvale Library Mural; Litter-Ature; St. James Park Artist Design Collaboration Phase I) were completed within their baseline budgets. In 2020-2021 notable Public Art projects delivered within the baseline budget are: Convention Center Mural Project; Cogeneration Façade Enhancement; Third Street Parking Garage Mural; Right the Blight Murals (7 murals); Equity Gallery; Holding the Moment Airport Exhibition; and Lincoln Avenue Special Projects.

Projects estimated to be delivered in 2021-2022 include the long-term enhanced design version of Sonic Runway at City Hall; three largescale projects at the Norman Y. Mineta San Jose International Airport; St. James Park Design Strategy Phase II; Pellier Park Art; the Midfield and Havana Mural; and the End of Watch Memorial.
