- D5: contamination due to construction, working on neighborhood history, neighborhood associations are requesting banners for COVID testing and vaccines, vandalism from the encampment at Mervyn's Way; how does Cash for Trash work; working with developers on how they are going to help with affordable housing.
- D6: potholes; seeing improvement with crumbling sidewalk and curbs, which is making the neighbors happy; trees being removed; racing; concerns over schools reopening and having resources available.
- D7: homelessness, encampments, unauthorized RV parking blocking line of site; side shows, illegal dumping, porch pirates, speeding, graffiti, mechanics using public parking; 2<sup>nd</sup> Saturday cruising causing friction; when will libraries/community centers reopen; can the City work with the County to get vaccines to people without internet or travel.
