Rezoning from the R-1-5 Single-Family Residence Zoning District to the PQP Public/Quasi-Public Zoning District and Special Use Permit to allow an approximately 14,983-square foot private gathering facility with an alternative parking arrangement (off-site parking and valet parking) on an approximately 1.86-gross acre site.
