Proposal Description, including the reason for the need and anticipated outcomes (Please describe how the proposal will affect services for San José residents, community groups, businesses, etc.):

Sideshows, reckless driving, and street racing have increasingly become quality of life issues for residents throughout San José, and District 4 is no exception. These incidents don't just disturb the peace: they represent a serious risk for the safety of our residents and the integrity of our roads and infrastructure. As enforcement alone has not sufficed in discouraging reckless driving, I am proposing quick-build traffic improvements for the roads and intersections in District 4 that have been most impacted by sideshow activities:

- Sierra Road, from Flickinger to Lundy
- The intersection of Mabury Road and Jackson Avenue
- Cropley Avenue, from Piedmont Road to Morrill Avenue

These intersections and road segments have been repeatedly brought to the attention of our staff by residents and have been noted by SJPD and DOT as long-time hotspots for sideshows due to their design.

These improvements would include installation of traffic control measures like paint, raised pavement markers, chatter bars, Botts' dots, and delineators to make roadways and intersections less amenable to sideshow activities. Intersection treatment may consist of curb extensions, median island extensions, and/or Botts' dots, strategically placed to reduce available space for drifting and donut movements. Corridor treatment may consist of quick-build materials adjacent to the bike lanes or in the median/centerline. DOT would need to review the roadway geometry, traffic demands, and access requirements to develop appropriate treatments.
