RECAP AND NEXT STEPS

There has been a series of three workshops that occurred between June 2019 and August 2021. The Village Plan will be presented to the Planning Commission for a recommendation and the City Council for adoption in early 2022.



WORKSHOP 1 – Community Values & Guiding Principles

The first workshop was held on Thursday, June 13, 2019 from 6:30 p.m. to 8:30 p.m. Participants were asked to help identify and discuss the assets and opportunities within the North 1st Street Local Transit Village area. Assets are places, buildings, and environments that are prized within the community. Opportunities are areas of improvement or change. These assets and opportunities were used to help create the Vision for this Village. The Vision will be the overarching concept for the community's preferred future for development and transformation of the corridor.

WORKSHOP 2 – Character Area Visioning

The second workshop was held on Monday, October 21, 2019 from 6:30 p.m. to 8:45 p.m. Participants were asked to establish the Character Areas for three segments of the Village. Each segment of the Village will have a unique Character Area. Character Areas are places that have a distinct feel based upon the types of development and intensities allowed. The feedback provided will be used to create the three Character Areas within this Village, which will then inform land uses, height, densities, Floor Area Ratios (FARs), preservation policies, open space/plaza policies, and transportation-related policies.

WORKSHOP 3 – Community Open House (Today's Workshop)

Staff will present the draft Village Plan and seek comments during this open house. After addressing these final comments, staff will prepare to present the Draft Village Plan to the Planning Commission and City Council for a recommendation and approval.

COMMUNITY MEETING CODE OF CONDUCT

The City of San José is committed to providing the information and opportunities to encourage residents to follow development activity in their neighborhoods and to actively participate in the land use development process. The intent of this community meeting today is to inform property owners, residents, and other interested parties about the proposed development, answer questions, and receive public comments. - Please use the Zoom Meeting “Raise Hand” function or press *9 on your phone to indicate you’d like to speak. Speakers will be called upon by staff and unmuted to speak.
- Depending on the number of speakers, each person will be called upon to speak only once. If time allows a speaker may be called upon more than once. Each speaker will be limited to two minutes of speaking time each time they are called.
- Persons on the Zoom Meeting call will refrain from behavior which disrupts the public meeting or which may intimidate others who wish to voice their opinions. This will include making loud noises, clapping, shouting, booing, hissing or engaging in any other activity in a manner that disrupts or impedes the orderly conduct of the meeting.
- Harassment of meeting participants including City staff will not be tolerated in any form. If a participant engages in harassing behavior, City Staff will end the meeting or remove the participant from the Zoom Meeting call.
