File No. C20-002 and SP21-021 - Conforming Rezoning from the LI Light Industrial Zoning District to the CIC Combined Industrial/Commercial Zoning District to allow by Conditional Use Permit the establishment of a day care center on an approximately 0.78-gross acre site. Project Location: 2586 Seaboard Avenue. Council District: 4.

- b. File No. SP20-005 and T21-015 - Special Use Permit to allow the construction of a 16-story office building with two towers totaling approximately 2.05 million square feet, including 37,603 gross square feet of ground floor retail and amenity space and 1,416,717 gross square feet of commercial office space with an alternative parking design (tandem and valet parking, parking stackers) and to allow up to 15 commercial condominium units and extended construction hours to include Saturday work from 7:00 AM to 7:00 PM and 24-hour concrete pours for up to 12 days per year over the course of construction (approximately 51 months), on a 3.57-gross acre site. Vesting Tentative Map to merge all existing five lots to one lot for up to 15 commercial condominium units on a 3.57-acre site. Project Location: Northwest Corner of South Almaden Blvd and Woz Way.
