Increase and Preserve Affordable Housing Opportunities

- 🏠 **788** households received Rental Assistance and Case Management (38% female head of household)
- 🏠 **5** agencies administering rental assistance



Respond to Homelessness

- ▲ **1,422** individuals received street outreach engagement, case management and rapid response
- ▲ **1,466** homeless persons received overnight shelter
- ▲ **41** families assisted with homelessness prevention services



Strengthen and Stabilize Communities – Public Services

- 🏠 **1,152** individuals received legal counseling, education, and outreach services
- 🏠 **198** seniors received direct services
- 🏠 **31** families received child care services



Strengthen and Stabilize Communities – Public Services

- 🏠 **508** individuals participated in community engagement activities
- 🏠 **61** business owners assisted
- 🏠 **37** new jobs created or retained



Strengthen and Stabilize Communities – Capital Projects

- 🏠 Evans Lane road humps
- 🏠 Community wireless infrastructure



Strengthen Neighborhoods – Non-Construction

Minor Repair Program = **235** households assisted
Enhanced Code Enforcement = **122** violations corrected





FY 21-22 Annual Action Plan Grants

- 🏠 COVID Response & Recovery through FY 21-22
- 🏠 Federal funding for COVID is three times normal entitlement grant program
- 🏠 Contracts will continue with 14 grantees in FY 22-23

- 🏠 2022-23 Annual Action Plan → winter & spring 2021
