Community and Economic Development CSA

1. City of San José Disparity Study

50,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by City Council, this action allocates one-time contractual services funding of \$50,000 to the Public Works Department to support a City of San José Disparity Study. This study will explore the potential barriers that minority, women, and veteran-owned businesses face in the City's contracting process and will recommend actions the City can take to increase participation from these groups. This funding, in combination with an Encore Fellow provided by the Mayor's Office, will begin the study and develop the full scope and cost to complete it. Staff will bring this information back to City Council in the fall. (Ongoing costs: \$0)

2. Economic Development Pre-Development Activities

100,000

This action adds one-time funding of \$100,000 to the Office of Economic Development and Cultural Affairs for Economic Development Pre-Development Activities. Pre-development funds are used to cover a variety of costs including: consultant services; studies; appraisals; pro-forma analysis; costs related to Development Services partner work; economic and fiscal analysis; and property management costs which are not supported by other departments. (Ongoing costs: \$0)

3. Diridon Station Area Development Planning

225,000

This action increases the Office of Economic Development and Cultural Affairs allocation for the Diridon Station Area Development Planning by \$225,000, fully funded through a reimbursement agreement with Google. This funding allows for continued staffing support through June 30, 2022 to manage project planning efforts and development review in the Diridon Station Area. (Ongoing costs: \$0)

4. District 7 Murals 30,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$30,000 to establish a District 7 Murals allocation to the Office of Economic Development and Cultural Affairs. This funding sponsors two mural projects to combat tagging and graffiti in frequently targeted areas within District 7. (Ongoing costs: \$0)

5. District 10 Murals 80,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$80,000 to establish a District 10 Murals allocation to the Office of Economic Development and Cultural Affairs. This funding supports the completion of three murals to combat graffiti in frequently targeted areas within District 10. (Ongoing costs: \$0)

6. Eastridge/Tully Business Association

100,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$100,000 to establish an Eastridge/Tully Business Association allocation to the Office of Economic Development and Cultural Affairs. The Tully Road Corridor is lined with many immigrant-owned businesses that include restaurants, stores, laundromats, and salons. This funding supports contractual services to establish the Eastridge/Tully Business Association. (Ongoing costs: \$0)

7. Friends from Meals on Wheels

130,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by City Council, this action allocates one-time funding of \$130,000 to the Housing Department to support Friends from Meals on Wheels, a program through the Health Trust to increase socialization opportunities for homebound seniors. (Ongoing costs: \$0)

8. Hispanic Foundation of Silicon Valley

50,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$50,000 to establish a Hispanic Foundation of Silicon Valley allocation to the Office of Economic Development and Cultural Affairs. In the 2020-2021 school year, the Hispanic Foundation College Success Center served more than 1,500 students and parents with 6,000 hours of student instruction in digital literacy, elevated math, coding, and dual high school and college-level courses. The Parent Academy also helped more than 850 parents obtain college information and resources for their children. This funding continues support of these programs through the Hispanic Foundation of Silicon Valley. (Ongoing costs: \$0)

9. Homeless Response Team Consolidation

(1,644,400)

This action eliminates the \$1.6 million of ongoing funding for the Homeless Response Team as part of a reallocation of funding in the Beautify San José program (BeautifySJ). As directed in the Mayor's March Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action is part of the city-wide programmatic consolidation of BeautifySJ under a single manager, including work related to the clean-up and abatement of homeless encampments. As part of the management consolidation strategy, a total of \$1.4 million (1.0 Community Programs Administrator position and non-personal/equipment funding) previously overseen by the Housing Department is shifted to the Parks, Recreation, and Neighborhood Services Department (PRNS) for homeless encampment activities. The consolidation mitigates cross-departmental challenges and increase efficiency and flexibility to support BeautifySJ initiatives and goals. Additional information regarding the consolidation of BeautifySJ is described in the PRNS section of this document. As well, as described in the Housing Department section of this document, 1.0 Staff Technician and 0.5 Senior Development Officer positions from the Homeless Response Team is funded directly from the Housing Department's Personal Services budget to assist with outreach efforts, coordinate with other City departments, and coordinate homeless data with PRNS. (Ongoing savings: \$1,644,400)

10. Measure E - Homelessness Prevention

3,800,000

As included in Manager's Budget Addendum #24, 2021-2022 Proposed Measure E Spending Plan, and included in the City Council-approved Mayor's Budget Message for Fiscal Year 2021-2022, this action allocates funding of \$3.8 million to the Housing Department for Measure E Homelessness Prevention and Rental Assistance support. The majority of funding (\$3.2 million) provides support to Destination: Home through the provision of financial assistance for households at risk of homelessness. The remainder of funding (\$600,000) provides for homelessness prevention services and support for survivors of domestic violence and sexual assault. This allocation is fully offset by a partial liquidation of the Measure E – 10% Homelessness Prevention Reserve. (Ongoing costs: \$0)

11. Safe RV Parking 20,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by City Council, this action allocates one-time funding of \$20,000 to the Housing Department to support Safe RV Parking. The City provides opportunities for homeless families and individuals living in RVs to park in safe places overnight. This funding is allocated for maintenance and repair needs for approximately ten to 15 RVs to improve their operability and habitability. (Ongoing costs: \$0)

12. San Jose Downtown Association

5,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$5,000 to the San Jose Downtown Association allocation to the Office of Economic Development and Cultural Affairs. This funding supports the San Jose Downtown Association's holiday marketing and fundraising efforts. (Ongoing costs: \$0)

13. School of Arts & Culture at Mexican Heritage Plaza - Avenida de Altares

75,000

These funds, in conjunction with School District funds, should train more than 100 educators or para-educators who can reach thousands of students and parents. (Ongoing costs: \$0)

10. Mattress Recycling Grant

99,225

This action establishes funding of \$99,225 to the Parks, Recreation and Neighborhood Services Department for the Mattress Recycling Grant program. This grant supports the BeautifySJ team's efforts towards reducing illegally dumped mattresses in four illegal dumping hotspots – Cadillac Drive, Chiechi Avenue, Florence Avenue, and Oakmont Drive – and promotes proper mattress recycling through the City's curbside junk pickup appointments and participation in Mattress Recycling Council (MRC) take-back programs. The project will also study the effectiveness of combining targeted outreach and installation of cameras with license plate readers at specific hotspot locations. The term of the grant is March 2021 through February 2022. (Ongoing costs: \$0)

11. San José Parks Foundation Tree Rebate Program

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$20,000 to the Parks, Recreation and Neighborhood Services Department for the San José Parks Foundation Tree Rebate Program. 12. San José Public Library Foundation Grants

This action establishes one-time funding for 1.50 Literacy Program Specialist positions, limit-dated through June 30, 2022 and \$50,000 in non-personal/equipment funding to the Library Department to allocate a grant award from the San Jose Public Library Foundation (SJPLF). This funding supports the Education and Digital Literacy Initiative by setting quality standards in City-operated or City-sponsored programming, measurement of results, and accountability for ensuring that public dollars are spent in areas of education that have the highest value and impact. The addition of the 1.5 Literacy Program Specialist positions is discussed in more detail in the Library City Department section of this document. (Ongoing costs: \$0)

13. Senior Nutrition Program

1,960,211

This action increases the Senior Nutrition Program within the Parks, Recreation and Neighborhood Services Department by \$1,960,211 to account for the County of Santa Clara's portion of the Senior Nutrition Program costs. The Senior Nutrition Program provides over 200,000 meals to the senior population on an annual basis at the City's 14 senior nutrition sites. Funding for the program is split; approximately two-thirds of the costs are covered by the County of Santa Clara Department of Aging and Adult Services, while the City covers the remaining one-third. This funding provides for approximately 1,109 meals per day for the senior population. (Ongoing costs: \$1,138,981)

14. Summer Youth Nutrition Program

43,953

This action adds one-time funding of \$43,953 to the Summer Youth Nutrition Program within the Parks, Recreation and Neighborhood Services Department to reflect grant funding awarded from the federal Summer Food Service Program. This program, administered by the California Department of Education Nutrition Services Division, provides lunches and snacks to qualifying youth during the summer months at Bascom, Mayfair, Roosevelt, and Seven Trees Community Centers. (Ongoing costs: \$0)

15. The Trash Punx 50,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action allocates \$50,000 for the Parks, Recreation and Neighborhood Services Department to contract with Trash Punx, a local grassroots organization currently assisting with the City's beautification efforts. In 2020, The Trash Punx organized the collection of nearly 125 tons of trash through over 70 events and 2,000 volunteers. They have shown an expertise in organizing diverse groups across all ages to achieve significant results to remove tons of trash for the City's local creeks and streets. (Ongoing costs: \$0)

16. VivaCalleSJ 2022 90.000

This action establishes the VivaCalleSJ 2022 grant allocation to the Parks, Recreation and Neighborhood Services Department in the amount of \$90,000. The grant funding from the County of Santa Clara Public Health Department supports two open street events planned in September 2021 and June 2022. With this funding, and resources from the San Jose Abierto program funding with the American Rescue Plan Fund, six miles of San José city streets will be closed for walking, biking, and other forms of physical activity. 152,561

This action increases the County of Santa Clara EMS Trust Fund allocation to the Fire Department in the amount of \$152,561 to recognize the County of Santa Clara First Responder Category C – Benefits to Emergency Medical Service Systems Users Funds grant. This action adds one-time funding of \$111,000 for the City match portion of a temporary Police Lieutenant position assigned to the Northern California Regional Intelligence Center (NCRIC). NCRIC is an all-crimes/all-threats fusion center providing analytic and technical resources to collect, evaluate, analyze, and disseminate timely information related to terrorist threats, criminal events, organized criminal activity, narcotics organizations, gang activity, and serial crime events to government and private sector agencies. NCRIC 2020 grant funds will pay for approximately \$133,000 of the position cost (discussed above), and it is anticipated that a future grant (NCRIC 2021, which will be recognized and appropriated later in 2021-2022) will support \$150,000 of the position cost, leaving a gap of \$111,000 which is the City's match. (Ongoing costs: \$0)

5. Parent Project - Santa Clara County

66,000

This action increases the Parent Project budget to the Police Department by \$66,000. Grant funding from the County of Santa Clara District Attorney's Office is awarded for the Parent Project program to assist parents of children with high risk behavior with the development of parenting skills, including the use of love and affection when disciplining them. The Parent Project has requested assistance from Police Department staff to accomplish the objectives of their program during the term of the grant – September 2017 through June 2022. As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$120,000 to establish the Citywide Tree Inventory Study allocation to the Transportation Department to complete an inventory and condition study of trees in City parks, libraries, and community centers, which will assist in future decisions related to tree maintenance and safety. 2. Park Strip Tree Planting

1. Business Tax System Replacement

4,130,000

This action adds one-time funding of \$4.1 million for the Business Tax System Replacement project. This funding will provide for system development and implementation, and initial hosting, licenses, and maintenance costs. The Business Tax System (BTS) is a critical system, coordinating the billing of over 80,000 businesses annually, generating collections of approximately \$30 million in annual revenue, and interfacing with other key systems within the City. The legacy BTS is no longer supported by the vendor and cannot be upgraded to a newer version. The \$4.1 million estimated cost reflects vendor responses to the Request for Information (\$3.5 million) and funding for system implementation and stabilization over an 18-month period beginning January 2022 (\$630,000), which includes temporary staffing equivalent of 3.0 Senior Office Specialist and 1.0 Analyst positions and non-personal/equipment. This project cost is partially offset by the liquidation of the Business Tax System Replacement Reserve (\$1.3 million), which was previously set aside from a prior contract to replace the BTS that resulted in vendor non-performance. The total annual operating costs, including ongoing licenses, system maintenance, and support, will be determined following the procurement of the system but are anticipated to be substantial and likely well in excess of \$100,000 per year. (Ongoing costs: \$0)

2. City Hall Audio System Enhancements

50,000

As directed in the Mayor's June Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action adds one-time funding of \$50,000 to establish the City Hall Audio System Enhancements allocation to the Public Works Department. This allocation funds ten new speakers, the cabling, connecting points, and other needed materials for the audio system that supports City Hall plaza events. (Ongoing costs: \$0)

3. City Outreach and Education Efforts

(50,000)

This action reduces the City Outreach and Education Efforts funding by \$50,000 one-time, from \$92,000 to \$42,000. There is sufficient funding available at the end of 2020-2021 to rebudget into 2021-2022 that ensures no service level impacts from this reduction. (Ongoing savings: \$0)

4. Commercial Paper Program Fees

175,000

This action establishes a Commercial Paper Program Fees budget to the Finance Department in the amount of \$175,000. The City's Commercial Paper program, funded by the City of San José Financing Authority, provides a low-cost financing tool to City Departments to fund construction projects and provides bridge financing until long-term financing is available. The Program uses very low short-term borrowing rates leveraging the City's strong credit rating and external bank liquidity to sell Commercial Paper to investors for terms up to 270 days. For the right to access this commitment, the City pays an annual commitment fee billed quarterly in arrears. To ensure an equitable allocation of the fee, the General Fund will bear the costs for the portion of the program that are not currently allocated amongst existing projects and capital funds. Based on forecasted usage, the portion allocable to the General Fund will not exceed \$175,000 in 2021-2022, though the level will be evaluated on an annual basis. (Ongoing costs: \$175,000)

5. Learning and Development Roadmap

500,000

This action allocates one-time funding of \$500,000 to the Human Resources Department for the Learning and Development Roadmap. This funding will be used to assess, create, and implement talent development activities for City employees. This aligns with the City Manager's "Powered by People" enterprise priority and City Roadmap program that focuses, in part, on engaging in efforts to support employee retention, engagement, and advancement through training and development, all of which are critical components of the internal strategic support necessary to facilitate community services. The funding will support rebuilding talent development programs and courses, as well as provide funding for temporary staff and vendor contracts that are needed to facilitate these initiatives. (Ongoing costs: \$0)

6. San José 311 Enhancements

750.000

As directed in the Mayor's March Budget Message for Fiscal Year 2021-2022, as approved by the City Council, this action allocates one-time funding of \$750,000 to the Information Technology Department as part of a two-year program to expand San José 311 internal capacity for coding and customer service. This funding includes the addition of a limit-dated Senior Analyst position and a limit-dated Enterprise Supervising Technical Analyst position, both effective July 1, 2021 through June 30, 2023, who will provide the technical support necessary to focus on (1) digital service delivery analysis/improvement; and (2) development of new services that bridge access, language, and ease of use barriers experienced disproportionately by underserved portions of the community. The success of these investments will be measured by at least five new services being placed into production by the end of 2022, expanding language support to include at least Mandarin and Tagalog, and higher customer ratings of service resolution. Funds will be used to maintain/scale cloud consumption services for virtual agent and chatbot services (\$150,000) and to pay for necessary licensure/vendor support for software products for these purposes (\$200,000). A San José 311 Implementation Reserve in the amount of \$750,000 is included in the General Fund Capital, Transfers, Reserves section for the second year costs of the program. Any ongoing funding needs beyond the two-year program will be evaluated as part of a future budget process. (Ongoing costs: \$0)
