Expanding Council Districts - Barbara Marshman

 As a safeguard, in the case that a council gets too large, council would go to a committee to review

- One option is to state in the charter for redistricting committee to review and make recommendations every 10 years on adding council districts given that they have access to the data and statistics to make an informed decision
- Other option would be that the mayor should convene a task force to review and make recommendations to add council districts
- Could there be an option to have a hybrid option 1 and 2?
- Should make a change in the charter, and note that it is the responsibility of the redistricting commission, and need to make a clear recommendation
- Make amendment to the charter under Redistricting Commission provision that it is part of charge under the Redistricting Commission, and make these recommendations 10 years from now
- Ask Mark if we have the power to add to the Redistricting Commission charge, preliminarily add that in
- We have consensus that it should be routinely reviewed and should be under charge of the Redistricting Commission
- Will talk further about a policy recommendation

Routine Charter Review Commission - Frank Maitski

- Will make changes to memo based on the preliminary vote from the last charter commission meeting
- Will add in provision of start meeting in 2028 and then every 10 years after
- Will send to Mark for review tomorrow
