Hi Redistricting Commission,

I'm David Noel from the Erikson neighborhood in District 9. I've lived in D9 for 34 years, and before that I grew up in D10. I have been President of Erikson Neighborhood Association for about 11 years. Before that I served on the Board of VEP Community Association in D10 for over 10 years, including 3 years as President. I have worked closely with the city council members, staff and residents of both districts for over 20 years.

Last night (10/21/21) I attended my first RC meeting. Many thanks to Commissioner Wright for publicizing the meeting on Nextdoor, and for Councilmember Foley for hosting a Town Hall this week on the topic. I believe most residents in our area are completely unaware of this redistricting effort and how it affects them. I can attest that nobody has reached out to Erikson Neighborhood Association to gather feedback on redistricting maps.

I am writing to urge you to keep the **Erikson, Thousand Oaks, Pinehurst and Tanglewood/Tatra** neighborhoods together as a community of interest within a single council district, preferably in D9. We are a contiguous residential area sharing SJUSD schools, the Guadalupe River (and future trail), Pearl Ave Library, Fire Station 13, shopping, dining, the Almaden Expressway corridor, Pearl Ave, Branham Lane, Hillsdale Ave, and much more. Branham and Hillsdale are both Vision Zero corridors, and Pearl Ave is in the process of getting similar safety improvements. We each have neighborhood associations and work together.

If our COI needs to change districts, then we have by far the most in common with D10. For example: the Almaden Expressway corridor, Almaden Lake Park, Almaden Community Center, SJUSD matriculating schools, shopping and dining, transit lines, and future urban villages along the Blossom Hill corridor from Blossom Hill to Hwy 85. **We have nearly nothing in common with D2.** If we move to D2, we could become a difficult-to-manage geographic appendix due to being inextricably connected to D9 and D10.

Please consider these factors as part of the redistricting process for the greater Erikson area:

- The Almaden Expressway corridor between Blossom Hill and Branham should be contained within a single council district. This is one of the most congested stretches of road in the city, and must continue be managed holistically as a city/county partnership. Adding an extra council district in this stretch would complicate constituent services immensely for both districts.
- The Blossom Hill corridor from Almaden Expressway to Hwy 85 is slated to include several urban villages, which will most significantly impact D9 and D10. This stretch should remain within those two districts,
- The COI for the greater Erikson area generally ends easterly at Hwy 87. The vast majority of our travels in our daily lives (work, school, shopping, dining, libraries, etc.) are northerly, westerly and southerly, so we should be in D9, D10, or potentially D6, but NOT D2.
- SJUSD boundaries run north/south from Almaden to downtown. It would be cleaner to keep our adjacent matriculating schools in D9 and D10 rather than carving some out to D2, which is served by OGSD & ESUSD.
- VEP Community Association in D10 was formed in 1969 and represents about 2000 homes in the contiguous residential areas of Gunderson, Vista Park, Carson and Parkview neighborhoods. I urge you to treat them as a

single COI and keep them in a single district, as honored by prior RCs over the past several decades. Here is VEP's map: <https://www.vepca.net/wordpress/about-us/>

- Erikson Neighborhood Association has a general meeting scheduled for Weds Oct 27, at 7pm via Zoom. Please reach out to me ASAP if you would like to present proposed maps at that meeting. That is currently our last planned general meeting of the year.
- Please ensure D9 neighborhoods are represented in RC meetings. If our commissioner is not available like last night, then we need an alternate to participate in commission discussion.
- In order to get constituent buy-in on a final map to be approved by City Council by mid December, I highly recommend keeping district boundaries as similar to current boundaries as possible (e.g. draft plans C3 and C4), with surgical changes and logical boundaries such as freeways wherever possible. Constituent outreach is essential, especially for major changes such as the Unity Plan and draft plan D.
- Please don't assume that well-organized groups who stack the public comment periods represent the majority of residents, who aren't even aware of redistricting due to lack of outreach.
- Districts with simple, compact, logical boundaries and minimum sprawl will generally be more efficient for councilmembers and their staff to manage, and result in higher constituent satisfaction and ability to serve increasing populations.

This was necessary because of the historical barriers and institutional obstacles that limit data on members of our community. You may also reference Plan# [68451 \(https://districtr.org/COI/68451\)](https://districtr.org/COI/68451), which contains pins for significant LGBTQ+ landmarks.

Lastly, our recommended district maps for the City of San Jose is included in Plan # [68463 \(https://districtr.org/plan/68463\)](https://districtr.org/plan/68463).

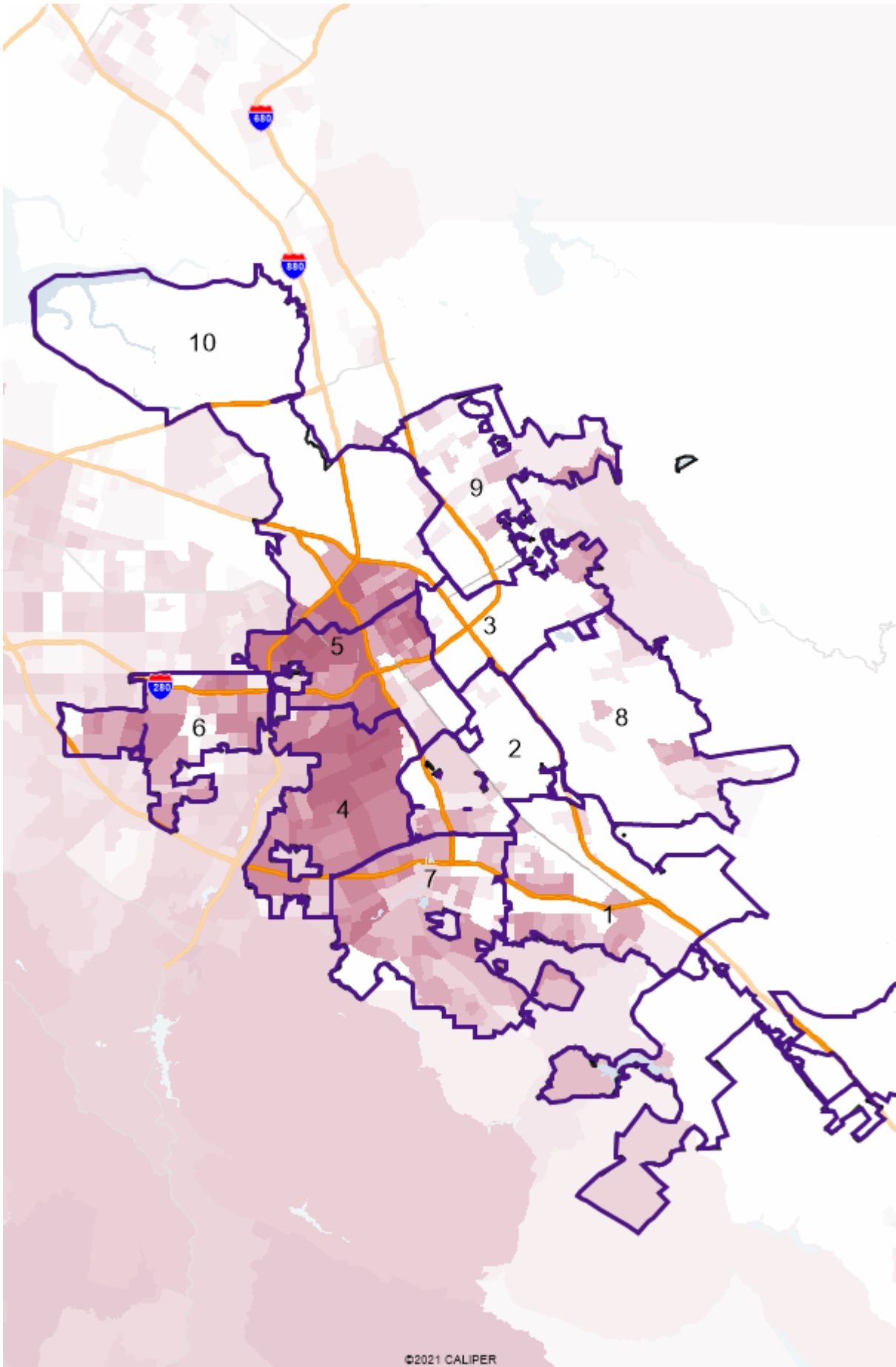

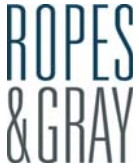

## EXECUTIVE SUMMARY

Geographically connected LGBTQ+ communities are communities of interest that should be considered in redistricting efforts. So long as an LGBTQ+ community can be shown to be within a contiguous population, the numerous shared social and economic interests of LGBTQ+ people require that LGBTQ+ communities be considered communities of interest. Thus, redistricting commissions must draw district lines that take effort to minimize the division of LGBTQ+ communities. In so doing, redistricting commissions are not limited to considering U.S. census data, and can consider other data sources such as personal testimony, community surveys, and polling. Indeed, the 2011 California Redistricting Commission considered LGBTQ+ communities of interest in drawing district lines.

## LEGAL FRAMEWORK

The Supreme Court of the United States has mandated that communities of common interest be considered in redistricting efforts.<sup>1</sup> Redistricting in the State of California is governed by Article XXI of the California Constitution. Article XXI sets out the process a 14-member Citizens Redistricting Commission (“Commission”) must follow as it draws the lines for California Assembly and Senate districts, federal congressional districts, and Board of Equalization districts. Section 2(d)(4) of Article XXI requires the Commission to consider communities of interest in establishing districts and defines “community of interest” as:

[A] contiguous population which shares common social and economic interests that should be included within a single district for purposes of its effective and fair representation. Examples of such shared interests are those common to an urban area, a rural area, an industrial area, or an agricultural area, and those common to areas in which the people share similar living standards, use the same transportation facilities, have similar work opportunities, or have access to the same media of communication relevant to the election process. Communities of interest shall not include relationships with political parties, incumbents, or political candidates.

California courts have developed factors to guide the analysis of whether a community falls within this definition. For example, the California Supreme Court illustrated the wide range of communities that fall within this definition, including communities with similar economic interests, travel patterns, and geographic interests.<sup>2</sup> Similarly, a California federal court explained that, “in defining communities of interest, [it] must look to socioeconomic status, education, employment, [and] health.”<sup>3</sup> Based on these factors, that court defined a Latino community “fac[ing] similar issues,” including issues “related to . . . public health,” as a community of interest.<sup>4</sup> Courts in other states have also developed factors for determining whether a community is a community of interest, including “share[d] . . . service organizations [and] . . . health clinics”<sup>5</sup> and “social, historical, and cultural bonds.”<sup>6</sup>

Scholars have supplemented the work of courts, also offering insight as to what factors are key in defining communities of interest. These factors include (1) discrimination related to socioeconomic status, education, health, and employment,<sup>7</sup> (2) historical affiliation,<sup>8</sup> (3) “cultural . . . and social ties,”<sup>9</sup> (4) “shared institutions,”<sup>10</sup> and (5) “similar values [and] shared interests.”<sup>11</sup>

### EXAMPLES OF “COMMUNITIES OF INTEREST”

Based on the factors described above, the Commission must determine what constitutes a community of interest within the bounds provided by the California Constitution. The Commission’s past redistricting efforts highlight the wide range of communities, *including LGBTQ+ communities*, that fall within the definition of community of interest. For example, when drawing Assembly, Senatorial, and Congressional districts, the 2011 Commission defined the following as communities of interest:

- Wine tourism industries;<sup>12</sup>
- Communities with recreational interests in a lake;<sup>13</sup>
- Populations across two cities that expressed in public testimony a shared sense of community;<sup>14</sup>

- A large concentrated population of Hmong immigrants;<sup>15</sup>
- Communities who expressed in testimony a shared commitment to coastal conservation;<sup>16</sup>
- An expansive retirement community with similar healthcare needs;<sup>17</sup>
- A community with similar social activities and nightlife;<sup>18</sup>

And most notably, several different communities of LGBTQ+ people.<sup>19</sup>

### LGBTQ+ PEOPLE IN LOCAL COMMUNITIES ARE “COMMUNITIES OF INTEREST”

As defined by the law, geographically connected LGBTQ+ communities are communities of interest that should be considered in redistricting efforts. So long as an LGBTQ+ community can be shown to be within a contiguous population, the numerous shared social and economic interests of LGBTQ+ people require that LGBTQ+ communities be considered communities of interest. Thus, redistricting commissions must draw district lines that take effort to minimize the division of LGBTQ+ communities.

Many LGBTQ+ people are geographically concentrated such that they may be considered a “contiguous population.” For example, LGBTQ+ people make up approximately 5.3% of adults within California.<sup>20</sup> And there are many geographically compact pockets of the LGBTQ+ community within California. For example, there is already documentation of compact communities of LGBTQ+ people in West Hollywood,<sup>21</sup> the Castro in San Francisco,<sup>22</sup> and in Hillcrest in San Diego.<sup>23</sup> These LGBTQ+ communities have already been considered by the 2011 Commission in drawing California Assembly District 17, Senate District 39, and Congressional Districts 12, 52, and 53.<sup>24</sup>

These are not the only potential LGBTQ+ communities that may be considered. There is no bright-line population percentage required to be considered a community of interest. In addition to the percentage of LGBTQ+ people in any given area, other factors such as the population growth or relative concentration of LGBTQ+ people may establish that there is a geographically “contiguous

population” required for a community of interest.<sup>25</sup> And these facts need not be established by U.S. Census data. Many other data sources, such as personal testimony, community surveys, and polling, have been relied upon in determining communities of interest.<sup>26</sup>

## COMMUNITIES OF LGBTQ+ PEOPLE SHARE COMMON “SOCIAL AND ECONOMIC INTERESTS”

LGBTQ+ people broadly share common social and economic interests, and individual communities may further share more specific interests. In particular, LGBTQ+ people share employment, healthcare, cultural, and historic interests, among others. These common interests have been recognized as creating a community of interest.

Employment: The court in *Luna* recognized shared employment interests as a valid rationale for a community of interest.<sup>27</sup> LGBTQ+ people share common interests in employment, and in particular, in prevention of employment discrimination. In a 2017 study, 59% of LGBTQ+ people believed that they had fewer employment opportunities because they were LGBTQ+.<sup>28</sup> Twenty percent of LGBTQ+ people reported experiencing discrimination based on sexual orientation or gender identity when applying for jobs.<sup>29</sup> The Supreme Court has recognized the need for employment protections on the basis of sexual orientation.<sup>30</sup>

In addition to the general LGBTQ+ employment concerns, certain LGBTQ+ communities may share further employment interests on the basis of being concentrated in certain fields. For example, nearly 40% of LGBTQ+ people, as compared to 22% of non-LGBTQ+ people, are concentrated in five fields: (1) restaurant and food services; (2) hospitals; (3) K-12 education; (4) colleges and universities; and (5) retail.<sup>31</sup> To the extent LGBTQ+ people are concentrated in these or other fields in a particular community, the particular interests of the fields may be further shared employment concerns.

Healthcare: The court in *Luna* also recognized shared health interests as a valid rationale for a community of interest.<sup>32</sup> LGBTQ+ people share many common healthcare interests, including barriers to access, risk of disease, and discrimination. LGBTQ+ people are at a heightened risk for

physical and mental health problems, due to associated “social and structural inequities.”<sup>33</sup> In addition to concerns regarding prevention of HIV/AIDS,<sup>34</sup> LGBTQ+ people are at heightened risk for mental health problems.<sup>35</sup> LGBTQ+ people are twice as likely to be uninsured, and report having difficulty accessing adequate, non-discriminatory health providers.<sup>36</sup>

In addition to general healthcare concerns, individual communities may be able to point to specific clinics or healthcare service providers in the community that service LGBTQ+ people.<sup>37</sup> This can be a particularly concrete, powerful example of a shared interest.

Cultural/Social Ties: Multiple courts and scholars have identified shared cultural interests as valid bases for a community of interest.<sup>38</sup> Over sixty percent of LGBTQ+ adults identified being LGBTQ+ as at least “somewhat important” to their overall identity.<sup>39</sup> And LGBTQ+-specific community engagement, such as pride events, LGBTQ+ rights activism, and LGBTQ+ organization membership, are important to large portions of the LGBTQ+ community.<sup>40</sup> Further, LGBTQ+ persons have shared cultural interests in the maintenance of queer gathering places.<sup>41</sup>

In addition to general cultural interests, individual communities may be able to craft more specifically tailored interests based on community-specific events, organizations, and spaces that cater to LGBTQ+ people. For example, specific LGBTQ+ businesses or social groups may provide concrete examples for a community of interest.

Historical Bonds: Courts and scholars have recognized shared historical bonds as valid bases for a community of interest.<sup>42</sup> LGBTQ+ people have shared a history of legal discrimination<sup>43</sup> and social discrimination that have resulted in shared political interests. This shared discrimination includes marriage inequality,<sup>44</sup> discrimination based on intimate relationships,<sup>45</sup> and ongoing discrimination

in housing and other accommodations.<sup>46</sup> The shared legal discrimination has resulted in common political goals among LGBTQ+ people to remedy the discrimination. Additionally, LGBTQ+ people have been historically underrepresented in elected office.

The shared history of legal discrimination of LGBTQ+ people includes the criminal justice system. LGBTQ+ people, and in particular transgendered people, are arrested and incarcerated at higher rates than non-LGBTQ+ people: they are 2.25 times more likely to be arrested and over 3 times more likely to be incarcerated.<sup>47</sup> These statistics reflect law enforcement's unequal treatment of the LGBTQ+ community and evince LGBTQ+ people's particular shared interest in law enforcement issues. Notably, oversight of law enforcement may occur at various levels of government. For example, the City of West Hollywood contracts the Los Angeles County Sheriff's Department, and not a local city police, to provide public safety services.<sup>48</sup> Thus, it is particularly important for LGBTQ+ communities to be properly represented at all levels.

Thus, due to the shared interests in employment and other economic concerns, healthcare, cultural/social ties, and historical bonds, LGBTQ+ people should be considered cohesive "communities of interest," and should be minimally divided in district drawing efforts.

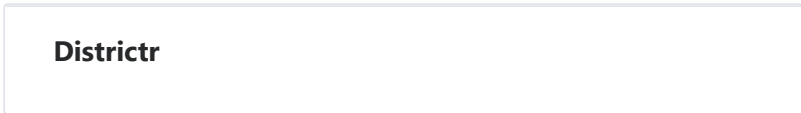

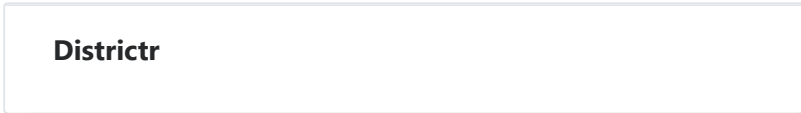

## Unity Map

### The Unity Map: Redistricting for Fair Representation


Redistricting – the redrawing of political district lines – takes place every 10 years, after new Census data are released. Current district lines have been major barriers to Asian-American political participation. Given what is at stake, the Asian American Legal Defense and Education Fund joined forces with the Center for Law and Social Justice at Medgar Evers College, LatinoJustice PRLDEF, and the National Institute for Latino Policy to develop a “Unity Map.”

Our Unity Map would make significant advances toward achieving fair representation for the city's communities of color. Asian Americans grew 32% over the past decade to over 1 million, or 13% of the population. Accordingly, the Unity Map achieves four Asian American majority State Assembly districts, compared to only one under current district lines. In Queens, where the Asian American community grew 300 times faster than the rest of the borough's population to almost half a million, the Unity Map creates one majority State Senate district for the neighborhood of Flushing/Bayside. Finally, the Unity Map unites splintered Asian American neighborhoods in Eastern Queens, Sunset Park, Brooklyn, and Manhattan's Chinatown within Congressional districts.


Latinos are New York City's largest minority group, constituting 29% of the City's 8.1 million residents. Under the Unity Map, there will be sixteen Latino majority State Assembly districts rather than the current thirteen, seven majority State Senate districts rather than the current five, and three Congressional districts rather than the current one. The Unity Map also preserves the number of Black State Assembly and Congressional districts for the City's 2.2 million Black residents, who constitute 26% of the City's total population.

Dear City Manager,

I am writing to express my thoughts about the Redistricting process.

First – We finally have a commissioner for D3. But I have now been told that commissioners are not allowed to talk to residents or exchange emails with residents outside of public meetings. Apparently, this is what the City Deputy Attorney told the D4 commissioner, who relayed the information to me. I emailed our D3 rep and never even received a reply.

What is the point of having district commissioners then?

And, residents are not allowed to have direct contact with Redistricting Partners, who are drawing the maps.

The only communication we have is residents listening to the commission and the Redistricting Partners person present during the weekly meetings. Then, we have 2 minutes to talk. There is no Q&A & no discussion (except between the commissioners).

We were told there would be revised maps each week based on public input. But there has been no map changes since the Oct. 14<sup>th</sup> meeting.

We presented our own map tonight. But apparently that was a waste of time. We were told that the two maps that the commission proposed last week will be the baseline maps.

As far as I can tell, we are now supposed to wait another week for some changes to be made based on what the commissioners want. Our D3 commissioner seems to have input from somewhere. Although she apparently isn't allowed to talk to residents.

Meanwhile, the Labor Union and non-profits have presented their map and it is the basis for one of the maps proposed by the commission. The Labor Union and non-profits hired a consultant early on. So, they have access to the same redistricting software that Redistricting Partners uses and are able to quickly generate maps that show differences with the current districts and all the data tables for presentation.

The residents in D3, who are most affected by the proposed changes, do not have this software which costs \$5,000 for one license. Meanwhile, we aren't able to see the street names on the proposed maps or make edits to show what changes we would like to submit. Apparently, it doesn't matter anyway since there is no one to receive or respond to emails.

People in San Jose are only now realizing that redistricting is happening and there are major changes being proposed that affect many neighborhoods. But it feels like it's just a matter of running out the clock now.

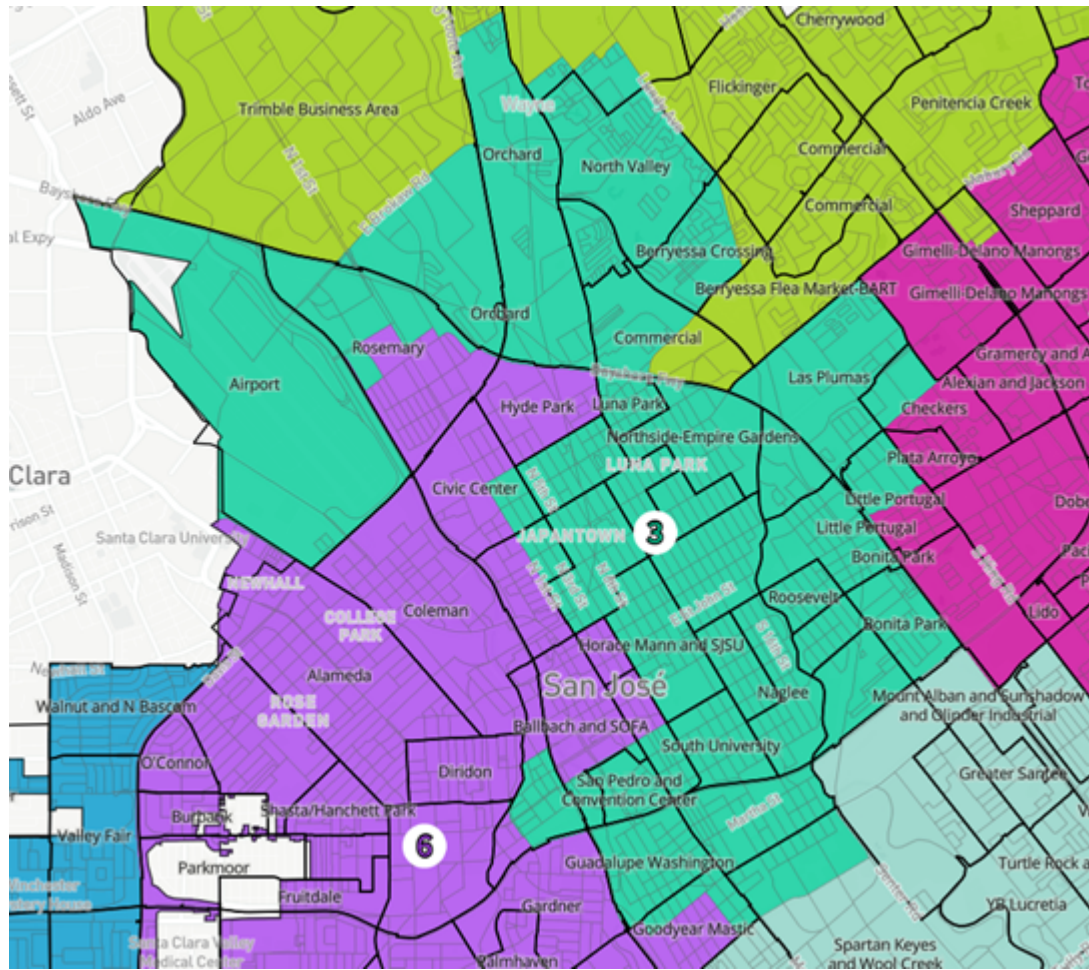
The only saving grace in all of this is that the City Clerk, Toni Taber, and the person who works with her, Megan Roche, do an amazing job of keeping things on track and they are very responsive.

Meanwhile, here are some snippets from the Labor Union's map that's the basis for one the commission's proposed maps. There's carving in and out and picking apart at specific areas. How is any of this considered a reasonable process? How is this map reasonable?

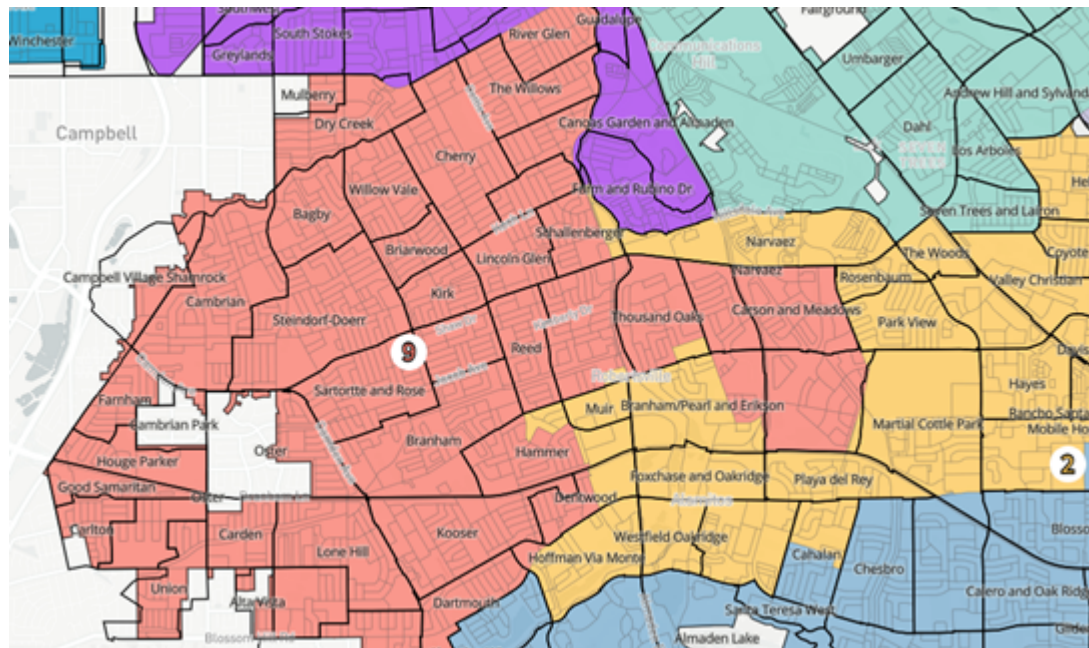

We don't have the capability to see the boundaries on the commission's proposed maps. The requirements for compactness, functional congruity and maintaining existing boundaries, as much as possible, don't seem to be a priority.

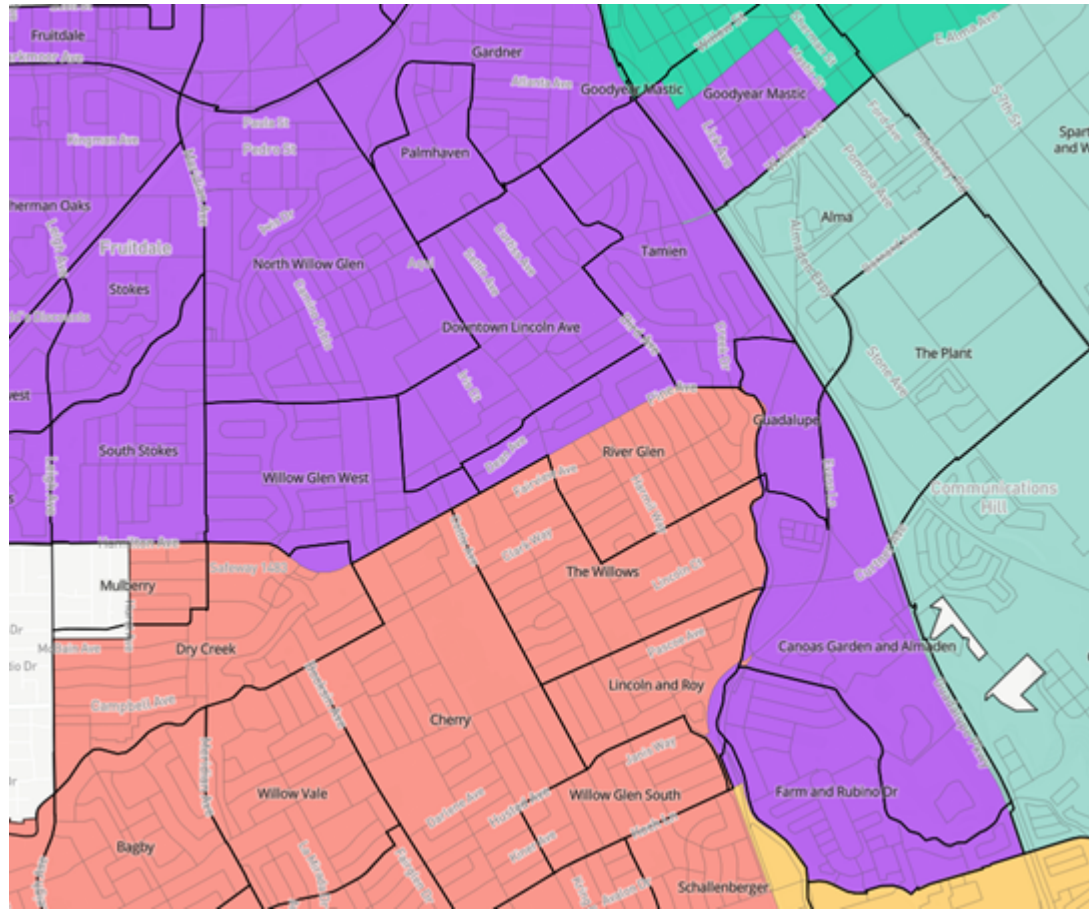
Here's our downtown District 3 on the Union map (barely squeaking through at 101 by the Berryessa Flea Market).

To the Redistricting Commission,

First, thank you to the members of the Commission for your time, your willingness to serve our communities, and for listening.

I am writing to support the C3 draft plan that was presented at the October 21 meeting, and to endorse the thinking behind the Community plan as well. I am strongly against the adoption of the Unity map.

My interest is parochial. I live in the Vendome, a small neighborhood north of Julian, south of Taylor and west of N. First Street. The Vendome is the site of the original 1777

Pueblo San José. Our neighborhood is closely allied with the Hensley Historic District located just across First Street. We are also closely allied geographically and politically with Japantown. We shop there, walk there, and know the people there. The Japantown light rail station is in fact in the Vendome. We have strong common interests and have worked constructively with the Hensley Historic District and Japantown to make the downtown area a clean, safe and comfortable place to live. The Vendome is undeniably part of downtown and belongs in District 3.

The Unity map does not honor the Commission's guidelines. It does not respect natural and rational geographic boundaries. Relocating the Vendome to District 6 ignores the fact that we are divided by the river, railroad tracks, Highway 87 and the airport. Also the Vendome has no communality of interests with District 6. District 6 does not share the challenges that face the residents in the downtown neighborhoods. District 6 doesn't share our proximity to the homeless encampments and is not affected by the route that unhoused people take from the river to the N. Fourth Street Salvation Army kitchens or the programs in St. James Park. District 6 does not have the density of social services, transitional housing and permanent supportive housing that impact downtown.

The Vendome is socio-economically and ethnically diverse. We have single family homes, apartment houses, condo complexes, and duplexes. People choose to live here for its diversity, the availability of public transportation, and the proximity to the downtown core. Our neighborhood is not even mentioned on the Unity map. I'm offended that people who have never set foot in our neighborhood would presume to determine its political future.

In that regard, the Unity map was constructed without consultation with community organizations and leaders. The Vendome has an active neighborhood association. The VNA's leadership was elected by our residents in a well organized and fair election. Tim Clauson, the president of the VNA, is accessible, open-minded and active in the community and the city as a whole. He can be reached. It was clear from the Unity map presentation on Thursday that nobody tried.

While the goals of the Unity map are admirable, the people who have promoted it have neither done their homework nor their outreach work, and they have produced a map that may well cause more disunity than anything else.

Whatever other decisions are made, please keep the Vendome allied with its downtown neighbors and the downtown core.

Dear Councilman Raul Peralez and Redistricting Commission,

**Please keep The Vendome Neighborhood in District 3 (with the downtown core).**

The new Redistricting Partners Map (Draft-C3) was a pleasant surprise compared to the original options and the presented “Community Map” is very similar. Both maps seem to logically start with the current district map (with existing neighborhoods mostly remaining intact) then make minimal adjustments to account for population changes, etc. and both maps keep the Vendome in District 3 which we support.

The “Unity Map” (Draft-C4) makes significant districting changes with the specific goal of increasing minority representation across the City. It also separates the downtown core into several districts (peculiarly splitting up Japantown) including carving out the Vendome into District 6-Willow Glen/Rosegarden (note: The Vendome is distinctly adjacent to Downtown but separated from the Rosegarden by a freeway, river, large park and shopping plaza). While the backing groups are presented as grassroots, we are seeing unity maps being introduced nationwide and they seem to have an established mailing list for support. *We believe in unity just not the map*; mainly questioning the extreme mapping changes and deviation from the reviewed redistricting principles.

There was also a third map presented that separates the Vendome and adjoining neighborhoods from Downtown into District 4-Alviso but we did not feel this is in consideration.

**It is essential the Vendome is kept as part of the downtown core (District 3) and with the neighboring communities (whole and together) in one district with the closely aligned Hensley and Japantown (and all Downtown centric neighborhoods). We share common interests/concerns and downtown development has major impact on our neighborhoods.**

The Redistricting Advisory Commission should follow the instructed trainings and City Charter: *“In any redistricting, the Council shall make the Districts as nearly equal in population as may be practicable, and may, in establishing the boundaries of the Districts, give consideration to (a) natural boundaries, street lines and/or City boundaries; (b) geography; (c) cohesiveness, contiguity, integrity and compactness of territory; and (d) community of interests within each District”* **and especially important that the Vendome remain with its neighboring communities in the downtown core (District 3).**

Hello Redistricting Commission,

I am Ted Earle, President of the Thousand Oaks Neighborhood Association (TONA). Only recently did we learn of your commission and the weekly meetings being held to gather feedback on redistricting maps. I believe many residents in our neighborhood are completely unaware of this redistricting effort and how it affects them.


I am writing to urge you to keep the **Thousand Oaks, Erikson, Pinehurst and Tanglewood/Tatra** neighborhoods together as a cohesive community within District 9. We are a contiguous residential area linked by many commonalities. We share SJUSD schools, Pearl Avenue Library, and Fire Station 13, as well as dining and recreation venues. The main thoroughfares of Almaden Expressway, Pearl Avenue, Branham Lane, and Hillsdale Avenue/Capitol Expressway are essential routes for our neighborhoods that present shared challenges. The impact of activity along the Guadalupe Creek - whether drought, flooding, fire, encroachment, or pollution - is felt directly or indirectly by all of us. Collaboration among our neighborhoods is essential to address these ongoing issues. We believe redistricting should be achieved in a way that least disturbs the valuable interconnectivity of neighborhoods with so many common interests, challenges and concerns.

It is crucial for Thousand Oaks to maintain our strong relationship with D9 staff - a relationship forged through triumph and tragedy. The revitalization of a long-neglected parcel of parkland was completed primarily due to a neighborhood-led effort, but would not have been possible without the unwavering support of then-Councilmember Rocha; the resulting Woodland Area officially opened in July 2018, earning us a Mayor's Commendation. Several months later, triumph turned to tragedy when Thousand Oaks resident Bambi Larson was brutally murdered in her home; we received immediate outreach and support from newly-elected Councilmember Foley and the D9 staff, strengthening our bond with D9. We are continuing our collaborative efforts to address health and safety issues in the Guadalupe Creek; D9 staff has been instrumental in scheduling creek cleanups and supporting TONA's Crime & Safety committee. Most recently, San Jose Parks Commission appointed Thousand Oaks resident Janny Choy to represent D9. Much of our interaction revolves around work that is ongoing, requiring the continuation of our well-established lines of communication, and depending on the essential foundation we have built with D9 staff over many years of collaboration.

In the interest of brevity, we would like to reference the October 22, 2021 letter submitted to your committee by our neighbor Dave Noel, of Erikson Neighborhood Association. The factors that he outlined in his letter are echoed and supported by myself, the TONA Board and many of our neighbors here in Thousand Oaks. We are in near complete agreement with the views expressed by Mr. Noel and want to add our weight to his points for your consideration.

support our neighbors.



