**Conforming Rezoning (C19-045)** from CG Commercial General to CP Commercial Pedestrian Zoning District on an approximately 0.32-gross acre site.

**Special Use Permit (SP19-031)** to allow the demolition of an existing 4,420 sf retail building, the removal of two ordinance-size trees, and the construction of a five-story mixed used building with 6,200 sf of commercial use, 16 residential units, and two levels of underground parking.
