Planned Development Rezoning from the Light Industrial, Heavy Industrial and Industrial Park Zoning Districts to the (R-M) Planned Development Zoning District. Planned Development Permit to allow th demolition of 64.800 square feet of existing industrial buildings, the removal of 26 ordinance-size trees and 30 non-ordinance size trees for the construction of 689 (including 375 affordable) multi-family residential apartment units with 4,000 square feet of commercial, and concession under state density bonus laws to reduce the amount of vehicle parking spaces. Vesting Tentative Map to combine six existing lots into two lots on an approximately 5.4-gross acre sites.
