I. Introductions

a. Albert Gehami, Digital Privacy Officer, City of San José, provided opening remarks and facilitated introductions.

II. Update on Privacy Policy implementation

- a. Albert Gehami provided updates on how the City has embedded Privacy into upcoming City projects
- b. Taskforce members offered to share existing educational material with San José, including:
 - i. Training for how to apply Privacy Policy
 - ii. Approach to rolling out City-wide training
 - iii. Specialty training for executives, council members and their aids
 - iv. General training for City staff
- c. To discuss additional material on Privacy trainings with Mike Shapiro, Chief Privacy Officer, Santa Clara County

III. Discussion of Privacy use cases in development

- a. Albert Gehami shared details on Monterey & Curtner "Vision Zero" project using a variety of traffic safety measures to reduce fatal accidents in a high-risk intersection
 - i. need for signage around intersection if engaging in traffic recording,

- ii. Need for policy if using automated license plate readers; Mike Shapiro to share Santa Clara County Policy on automated license plate readers
- iii. potential for more outreach focused on privacy
- b. Albert Gehami shared details on DoT's Traffic metrics data collection translating video footage into a set of anonymous traffic metrics (e.g., # of cars at an intersection, # of near-collisions) to study and improve intersection safety
 - i. Discussed need to confirm camera footage is deleted on device with no accidental storage
- c. Albert Gehami shared details on Police open data portal
 - i. Confirmed with Taskforce that data is not a granularity that could lead to identification
 - ii. Stephen Caines, Technology and Innovation Policy Advisor, City of San José shared information on additional Police open data portal.
