- a. **ACTION: Approved the design for artwork on bicycle lockers on King Road adjacent to School of Arts and Cultural (SOAC) at Mexican Heritage Plaza by from Jovenes Activos, a project of SOAC and the City's Department of Transportation.** (District 3)

Introduced by Sr. Public Art Project Manager Lynn Rogers; presented by Edgar Ochoa of School of Arts and Cultural and Grasiela Diaz of CSJ Department of Transportation

It was noted that some of the designs are still in concept stage and will develop further; staff confirmed that the PAC can approved the designs as presented and SOAC can rprovide an update to the PAC at a later date. It was also clarified that there will be a total of four artworks, two on each of the two lockers – one each on the streetside and one each on the sidewalk side.

E. Ochoa detailed the community engagement process involving the youth, the families who participate in events at SOAC, on social media and more. There was a lot of response to the the question "What kind of mural would you like to see." This engagement work and feedback will be used to inform a range of projects. He will follow up with sending a document with the community input from Somos Mayfair and what the community wants in murals/art in the Eastside.

Commissioner Rosenthal congratulated SOAC and DOT on involving youth in this type of art project.

In response to questions, E. Ochoa clarified that the artists' age range is 12 -17 years old and that they will be workign with local artist mentors. The possibility of tagging was discussed.

PAAC member C. Shipp commented that she is excited to see this type of project come to fruition. PAAC member H. Lubin noted that she likes the process they used and thanked SOAC and E. Ochoa for engaging youth in the project.
