OVERALL REMINDERS

- 1. Your session will time out after 30 minutes of inactivity. There is no prior warning so please remember to save your work frequently by clicking the issue icon.
- 2. <u>Save your work often!</u> WebGrants only saves your work when you click the icon. If you go to another section without saving, you will lose the work you did.
- 3. <u>All required fields in a section must be saved prior to clicking the SAVE icon.</u> If you try to click the SAVE button and you get an error message: "Please complete all required fields," this means that there is at least one required field (i.e., question) that you have not yet completed; required fields are marked by a red asterisk. TIP: If this you get this message, you can place a random character (like an "x" in each required field and then the system will allow you to save. Make sure that you have replaced all placeholders with actual responses before submitting your application.
- 4. <u>Cutting and pasting responses from a Word document.</u> Some applicants choose to compose their answers using Microsoft Word and then cut and paste their responses into WebGrants. After cutting and pasting, double check that the entire response has been transferred to WebGrants. NOTE: WebGrants will cut off any responses after the maximum character count has been reached, and it will not let you know that any words have been cut off.
- 5. <u>Formatting issues when cutting and pasting.</u> If you experience difficulties cutting and pasting from a Word document into WebGrants, try this method: 1) highlight and copy the section you want to paste, 2) put your cursor into the field and hit the space bar once, 3) click the icon indicated in the **red circle** on the formatting tabs and follow the directions for pasting your text into the pop-up dialogue box and 4) click the green button labeled "Insert."

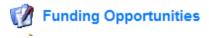

If you will have several people working on the application, <u>make sure that people do not create a</u> <u>new application every time they enter the system</u>; have everyone work on the one application that is initially created in this step.

For future reference, in order to return to an application that you already created, log on to the system; do steps #1-3. At the top of the screen you will see your Project Title (the one that you will create in Step #5). Click on your Project Title, and, then you can click on the application section that you want to return to.

2. General Information

Enter your Project Title (*Example: FY2022-23 Operating Grant – ABC Theater*) and select the proper drop down values for Primary Contact, Authorized Official and Organization then click

To see the full application at any time, click on the **APPLICATION DETAILS** link and you will be able to view and print it to PDF. Unfortunately, you can't select only certain sections to view, the whole application gets converted to a PDF.

- 3. Sources of Funds Statement After completing Step #2, click on Sources of Funds Statement Application Form link:
- (a) Scroll up and click on the \checkmark Edit link to begin filling out this form.
- (b) Enter response(s) for **Project Description** (Example: **"Present a season of theater programs during FY2022-23"**) and **Grant Amount Requested** in the form.

Note: The number you put into the **Grant Amount Requested** field has no bearing on your grant award and is not considered by the review panel in any way. (This info is asked only for City-wide data collection purposes.) Refer to Section 3.2 in the OpG Guidelines for how grant levels are determined in the OpG program. If you would like a very rough estimate of a potential grant based on past funding levels, you can utilize the **Reference Grant Calculator** on the OCA's Operating Grant webpage.

(c) After you are done, click the **save** icon.

If you are unable to click into the fields, or if you are returning to the document to edit previous info, then scroll up and click on the Edit icon, and the fields should be opened so you can enter or revise information.

- (d) In order to enter response(s) for *Total Amount of Other City Funds for Project* and *Total Amount of External Funds for this Project*, you <u>must click on the highlighted blue</u> Add link on the far right of the table.

If you have no Other City Funds for this project, you must click on the blue Add icon to the far right and then type in "n/a" in all the fields (Program/agency, Fund Status, Use of Funds); leave the Amount at "\$0."

If you do anticipate other City funds (cash grants), click on the Add link and complete the required information. Repeat this step for each different City funding source that you are budgeting.

Later, if you want to change your responses in the tables click on the highlighted blue <u>text</u> in the Program/Agency column.)

ii.) <u>Special instructions for *Total Amount of External Funds for this Project*</u> for Operating grant applicants:

After you hit the Add icon, write in "Various" under PROGRAM/AGENCY and select "Anticipated Revenue" from the drop down menu for FUND STATUS and write in "Arts Programming" for USE OF FUNDS. For the AMOUNT, enter your total projected revenues** for FY2022-23 <u>minus</u> a) your operating grant placeholder amount and b) any other City grants that are you are budgeting.

Example: If your organization budgeted total operating revenues of **\$200,000**, and you had an Operating Grant placeholder amount of \$20,000 and you budgeted a \$10,000 grant from another City department, then you would insert \$170,000 in the AMOUNT line (i.e, (**\$200,000** – (\$20,000 + \$10,000)). When you are done, it should look something like this (Of course, your figure in the "amount" line will be different, however!):

If you have only entered placeholder values in these fields it is suggested that you click the save button and then click on the Go to Application forms, which will allow you to exit the form and return later to enter correct values. If you are satisfied with responses, click on the Mark as Complete link.

4. Cover Sheet After clicking on the Mark as Complete or Go to Application forms in Step #3, click on the **Cover Sheet** form.

5. **Narrative** After clicking on the Mark as Complete or Go to Application forms in Step #4, click on the **Narrative** form. Complete this form by clicking directly into the field boxes to enter text.

After entering text, click on the **bare** icon.

Please use 12 point font for the benefit of your application readers!

Note #1: WebGrants does not have a running character count function. Spaces and formatting code count as characters. If you feel if you are nearing the limit, you can hit the save button, and it will tell you whether you have exceeded the character limit, which counts spaces and formatting code. (Alternately, you can compose the answer in a Word document and determine the character count in Word. If you do this, note that that Word will generally undercount the characters because it may not count paragraph returns and formatting as characters and WebGrants does.)

Note #2: If you are cutting and pasting from a word document, it's recommended that you **cut** and paste the answers <u>one question at a time</u>, and HIT THE SAVE BUTTON AFTER EACH QUESTION. For example, after you've cut and pasted the answer to one question, hit the save button, then cut and paste the answer to the second question.

If you are unable to click into the fields, or if you are returning to the document to edit previous info, then scroll up and click on the \Im to not the fields should be opened so you can enter or revise information.

6. Attachments After clicking on the Mark as Complete or Go to Application Forms in Step # 5, click on the Attachments form.

All Attachments must be in PDF format. The only exceptions are:

Item #10a-c. Supporting Materials. Acceptable formats are: PDF, JPEG or Word document with a hyperlink.

Item #11. Optional Work Sample. Work Samples are optional but highly recommended. Acceptable formats are: Word document with a hyperlink to YouTube or Flickr or website; audio file (YouTube, MP3, or Flickr); video file (YouTube or Flickr); or Flickr Photo Gallery.

Complete this section by executing the directions below.



- a. Click on the highlighted text for each requested attachment;
- b. Click on the Browse button to select the requested file to attach;
- c. Enter text in the description field box;
- d. Click on the Save link; and
- e. Repeat these steps for each requested document.

If you need to remove an attached document, click on the delete link. Then OK on the drop down message box.

7. **Application Signature Form** After clicking on Go to Applications or Mark as complete in Step #6, click on the **Application Signature** Form. This step should be done once you have completed answering all of the questions and filling in placeholders.

- 8. **Preview the application** To Preview the application, click on the **Application Details** icon and you will have the option to view what you have done so far and print to PDF if desired. You can actually click the **Application Details** link at any time in the process.
- **9. Submit the Application** To submit the application, the COMPLETE column must have a check mark by each application component as shown in the image below:

Click on the Submit icon and then on the OK button to complete the application. This will lock the application and no further editing will be allowed.

IMPORTANT NOTE: Prior to submitting, please be sure to preview the entire application (see above step) to make sure that you have responded to each question to your satisfaction, and that you double checked that all "place holder" responses (i.e., misc. characters that you placed in required fields so that you could save the application and return for future editing later) have been replaced with actual responses. After you submit the application, you will not be able to make any revisions or changes.

Once the Submit button has been successfully clicked, you should immediately see a confirmation message screen from WebGrants that the system has accepted your application.

Applicants bear the burden of proof that their application was submitted successfully. Applicants are strongly advised to print this confirmation screen as proof of their submission.

<u>REMINDER</u>: Please make note of the deadline. WebGrants will not accept applications submitted even a minute after the deadline so please plan to submit the application *at least 7 days prior* to the deadline so that you have time to resolve any unanticipated issues.

Planning Tips for a Successful Application Submittal Experience

- GET STARTED EARLY. Set your personal deadline to submit the application at least one week prior to the posted deadline. You take a significant risk by waiting until the deadline to submit the application! WebGrants does not accept late applications.
- READ GRANT GUIDELINES THOROUGHLY BEFORE STARTING THE APPLICATION. The Guidelines contain important information you will need about the supporting materials (Section 5.4) and the preparation of attachments (Section 5.5 & 5.6). In addition, it is helpful to refer to evaluation criteria when writing the application narratives.
- LOCATE AND CONVERT REQUIRED ATTACHMENTS TO PDF FORMAT AS EARLY AS POSSIBLE. If you do not have in-house capacity, many large copy centers have services that will convert paper or electronic documents to PDF. Call in advance to locate a center and do this as soon as possible.
- If you are submitting an <u>optional work sample</u>, make sure you are familiar with the required formats: Word document with a hyperlink to YouTube or Flickr or website; audio file (YouTube, MP3, or Flickr); video file (YouTube or Flickr); or Flickr Photo Gallery.
- Select and convert <u>supporting materials</u> to the acceptable format as early as possible. Supporting Material(s) should be submitted online as Attachments in WebGrants. Acceptable formats are:
 PDF, JPEG and Word document with a hyperlink to a webpage. (*Hard copies of application materials will not be accepted.*)
