The industry was amongst the most impacted and the travel segments that historically have come to San Jose (business and group) are forecasted to be the longest in recovery. These impacts have been compounded because the funds that would typically be utilized to market and build demand for travelers are greatly reduced. The CVB budget which is the primary engine for rebuilding travel demand to San Jose is tied to the hotel transient occupancy tax, and has been greatly reduced. While many other California cities supplemented their CVB's budget with federal and state recovery funds – the San Jose CVB saw funds reallocated out of its budget this fiscal year to assist non-profit arts groups. With the expected long-tail of the pandemic, a working group to look at solutions to help assist hospitality workers still impacted by the pandemic while looking at ways to help energize travel demand to San Jose (benefitting the workers and owners of the hotels, restaurants, arts groups, and other businesses that benefit from travel and tourism) would be a critical piece in San Jose's recovery.

Lease negotiations and/or lease assistance - Since the end of the moratorium, many businesses are being forced out of their locations despite the small business owners' efforts to negotiate and/or request for reasonable repayment schedules.  3. Staffing shortages - Many small businesses continue to experience a lack of employees, particularly in the restaurant and hospitality industries  4. Pivoting, changing their business models and/or moving to a digital space: Many small business owners are still trying to refine their new business models which includes converting many of their business operations online. Although many businesses have successfully transitioned, there are still businesses that have not or do not know how to best utilize the various platforms and need a lot more support to do so. The learning curve for the mom and pop owners makes it difficult for them to learn new skills and also run their businesses as they are still in survivor mode.  5. Other issues - Recovery is not the only issues small businesses are dealing with they continue to need support due to language barriers, ADA lawsuits (even in the middle of the pandemic), Human Resource support on new wage laws, sick leave and sexual harassment requirements as well as recent legislative changes as of 2022 to ensure compliance.  I think the teams. i.e. the Small Business Recovery team, need to create subcommittees within their teams, composed of 2-3 people to find some of the root causes for these issues and what existing services to remedy these issues and then suggestions to create new resources or programs, if possible, to fill in the gaps.
